

#### **RESOLUTION NO. 0348-2024**

DECLARING VALID AND OPERATIVE THE ANNUAL BUDGET OF PINIG-LIBANO. DUMALINAO, ZAMBOANGA DEL SUR FOR THE CALENDAR YEAR 2024, AMOUNTING TO TWO MILLION FOUR HUNDRED THIRTY-FOUR THOUSAND TWO HUNDRED SEVEN PESOS (PHP2, 434, 207.00), SUBJECT TO ALL ACCOUNTING AND AUDITING RULES AND PROCEDURES.

WHEREAS, presented for consideration and appropriate action is the Annual Budget of Barangay Pinia-libano, Dumalinao, Zamboanga del Sur for CY 2024. amounting to Two Million Four Hundred Thirty-Four Thousand Two Hundred Seven Pesos (Php2, 434, 207.00), with approved Barangay Appropriation Bill No. 1 S. 2024;

WHEREAS, Section 447, (a), (1), (i), Article III, Title II of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan shall review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

WHEREAS, programs, projects and activities reflected in the budget documents are in conformity with existing laws, rules, and regulations set forth on Book III,

Chapter 4, Section 391 paragraph (a). Sub-paragraph (3) of the Local Government Code of 1991 which states that:

(3) Enact Annual and Supplemental Budget in accordance with the provision of this Code;

# FINDINGS & RECOMMENDATION

1.That, the cost of Personal Services in the amount of **Php 1,112,497.92** is within the 55% Personal Services (PS) cap limitation.

However, Noted that your 2023 and 2024 Annual Budget had indicated that the provisions for honoraria is not in accordance with budgeting rules under LBC 149 Section 8.2 "to implement at a uniform percentage when funds are not available. (See attached separate sheet of PS computation of rates.) Be informed that in 2023 your respective honoraria is at the ranges of 47% to 50.31%. (See the honoraria matrix). By 2024 you attempted to remain the same, however, we suggest that you may apply uniformly the rates for your respective honoraria when funds may warrant in the coming years to correct said lapses.

- 2. That, the 20% Economic Development Fund (EDF) in the amount of Php 478,941.40 shall be spent or disbursed solely in accordance to the guidelines of the DBM-DILG Joint Memorandum Circular No. 1 Series of 2020 dated Nov.4,2020 "GUIDELINES ON THE APPROPRIATION AND UTILIZATION OF THE 20% OF THE INTERNAL REVENUE ALLOTMENT FOR DEVELOPMENT PROJECTS" and JMC 01 dated April 27, 2023 of which the Barangay Development Council (BDC) shall programmed the Priority Development Projects of the barangay thru a resolution and duly approved and adopted by the Sangguniang Barangay and be accordingly included in its AIP 2024.
- 3. That, the 10% Sangguniang Kabataan Fund (SKF) allocation in the amount of Php 243,320.07 shall be disbursed solely for Youth Development projects, plans and programs as provided by duly approved SK Resolutions and must be under the supervisions and administered by the Sanggunian Kabataan under DBM –DILG –NYC JMC # 1 s. 2019 as amended under LBC No. 148 dated December 23, 2022
- 4. That, the **5% LDRRMF** appropriation in the amount of **Php 121,660.35** shall be used to support disaster risk management activities such as, Pre-Disaster preparedness programs and activities, Relief and recovery programs in the communities or areas stricken by disaster, calamities, epidemics or complex of emergencies on the locality as provided under the NDRRMC-DBM –DILG JMC # 1 S 2013 DATED 3/25/2013 on the Utilization of Local Disaster Risk Reduction and Management Fund .

#### COA Cir. 2012-002 states that:

"A Local Disaster Risk and Reduction Management program (LDRRMP) for the DRRM program shall be prepared annually. It shall present the 30% allocation for QRF in lump sum and the allocation for disaster mitigation, prevention and preparedness with the details as to project and activities to be funded. The LDRRMFP shall also include under a separate caption, the list of projects and activities charged to the unexpended LDRRMF of previous years."

- 5. That, the amount of **Php 121,660.35** be disbursed in conformity with the approved GAD Plans and Programs of the Barangay as provided under the guidelines on the utilization of its appropriations as provided on the RA 7192, RA 9710 and PCW DILG-DBM NEDA JMC2016-1 dated 1/12/2016.
- 6. That, the amount of **Php 12,166.04** be disbursed for the purpose/purposes as appropriated for the expenditures intended for the Senior Citizens RA 9994
- 7. That the amount of Php 12,116.03 be disbursed for the purpose/ purposes as appropriated for the expenditures intended for the PWD RA 9442 . .
- 8. That, the amount of **Php 24,332.07** be disbursed for the purpose/purposes as appropriated for the expenditures intended for the Barangay Council for the Protection of Childrens (BCPC) Funds RA 9344.
- 9. That, the amount of Php 24,332.07 be disbursed for the purpose/purposes as appropriated for the expenditures intended for the Barangay Anti Drug Councill (BADAC), . Please be informed that the requirement for the provision for BADAC is any substantial amount.
- 10. The MOOE provided in your budget has an aggregate amount of P291,130.76.00 when computed mathematically which you declared only as P281,130.70, thus contributing to the excess amount of total appropriations of P8,000.06 which will definitely make this budget defective and could be declared as inoperative in toto.

Among the 18 appropriation items, we found out that an appropriation is provided for Uniform for barangay officials amounting to P6,000.00, which have no legal basis. By then after adjusting this figure of P6,000.00 still an excess amount exist thus we persistently require you to revise and adjust your MOOE from wherever you may deem appropriate to adjust to cover and wipe out the excess amount of P2,000.06. Please furnish us then on the action taken for this.

11. And, that all procurement of the above appropriations and all other appropriation items should be in compliance on the provisions under **R.A. 9184**, the Government Procurement Reform Act and its Rules and Regulations and should formed part or entered in its ANNUAL PROCUREMENT PLAN (APP) of the Barangay, subject however to the usual Budgeting, Accounting and Auditing Rules and Regulations.
