## **RESOLUTION NO. 0361-2024**

APPROVING THE AUGMENTATION OF FUNDS FROM THE SAME EXPENSE CLASS OF PERSONAL SERVICES OF THE UNAPPROPRIATED PERSONAL SAVINGS UNDER RESOLUTION NO. 0334-2024 DATED JUNE 3, 2024, AMOUNTING TO TWO THOUSAND PESOS (PHP2, 000.00) IN THE OFFICE OF THE SANGGUNIANG BAYAN TO COVER THE BUDGET DEFICIT OF TERMINAL LEAVE BENEFITS OF FORMER VICE MAYOR LORENZO S. ALCANTARA.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra to approve the augmentation of funds from the same expense class of Personal Services of the Unappropriated Personal Savings under Resolution No. 0334-2024 dated June 3, 2024, amounting to Two Thousand Pesos (Php2, 000.00) in the Office of the Sangguniang Bayan to cover the budget deficit of Terminal Leave Benefits of Former Vice Mayor Lorenzo S. Alcantara:

WHEREAS, under Section VII of Appropriation Ordinance No. 2023-12-497 provides that the Municipal Mayor and the Municipal Vice Mayor are hereby authorized to augment any item of appropriation in this budget for their respective executive and legislative officers by the way of Executive Order and Resolution respectively, from appropriation savings, within the same expense class of the office;





WHEREAS, the available Unappropriated Personal Services Savings in the Office of the Sangguniang Bayan that shall be used for the augmentation of funds from the same expense class of Personal Services to Personal Services to cover the budget deficit the Terminal Leave Benefits of Former Vice Mayor Lorenzo S. Alcantara amounting to Two Thousand Pesos (Php2, 000.00);

**WHEREAS**, the amount indicated above shall be made for augmentation to the items of the same expense class, from PS to PS of the Sangguniang Bayan Office of the Local Government Unit of Dumalinao;

**WHEREAS**, the Municipal Budget Officer had certified that as per book of accounts of the said offices, the item was found out available as of date and can be a source of augmentation;

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE,** premises above-considered, on motion by **HON. FREDERICK R. BALANDRA**, the body resolved, as it hereby resolves to approve the augmentation of funds from the same expense class of Personal Services of the Unappropriated Personal Savings under Resolution No. 0334-2024 dated June 3, 2024 amounting to Two Thousand Pesos (Php2, 000.00) in the Office of the Sangguniang Bayan to cover the budget deficit of Terminal Leave Benefits of Former Vice Mayor Lorenzo S.
