RESOLUTION NO. 0364-2024

DECLARING VALID THE BARANGAY ORDINANCE NO. 05 SERIES OF 2024 OF SUMADAT, DUMALINAO, ZAMBOANGA DEL SUR, ENTITLED "AN ORDINANCE PROHIBITING THE LITTERING OF SOLID WASTE IN THE BARANGAY SUMADAT, DUMALINAO, ZAMBOANGA DEL SUR, AND PROVIDING PENALTIES FOR VIOLATION THEREOF."

WHEREAS, presented for consideration and appropriate action is the Barangay Ordinance No. 05 Series of 2024 of Sumadat, Dumalinao, Zamboanga del Sur for review, which was referred to the SB Committee on Rules, Good Government, and Public Accountability for further study;

WHEREAS, Section 447, (a), (1), (i) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the sanggunian bayan, as the legislative body of the municipality shall review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

WHEREAS, the aforesaid ordinance was then reported back to the August Body with the following findings and recommendation:

"Section 389, (b), (9) of Republic Act No. 7160, otherwise known known as the Local Government Code of 1991, states that for efficient, effective, and economical governance, the purpose of which is the general welfare of the barangay and its inhabitants pursuant to Section 16 of this Code, the punong barangay shall enforce laws and regulations relating to pollution control and protection of the environment"; The Ordinance is in line with Republic Act 9003 "Ecological Solid Waste Management Act of 2000". The penalty imposed is within their powers;"

WHEREAS, the Committee recommended to declare the subject ordinance valid;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. HERMES B. CABALES, the body resolved, as it hereby resolves to declare valid the Barangay Ordinance No. 05 Series of 2024 of Sumadat, Dumalinao, Zamboanga del Sur, entitled "An Ordinance Prohibiting the Littering of Solid Waste in the Barangay Sumadat, Dumalinao, Zamboanga del Sur, and providing penalties for violation thereof."

BARANGAY ORDINANCE NO. 05 SERIES 2024

AN ORDINANCE PROHIBITING THE LITTERING OF SOLID WASTE IN THE BARANGAY SUMADAT, DUMALINAO ZAMBOANGA DEL SUR AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, Section 16 of Republic Act No. 7160 also Known as the Local Government Code of 1991, provides that local government units shall exercise power necessary and appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare:

WHEREAS, it has been observed that almost every day some people are carelessly throwing away cigarette butts, cellophanes, candy/bread wrappers in other public places which make our environment untidy and unsightly to look asides from becoming a virtual spawning ground of decease;

EXCERPTS FROM THE MINUTES 1 REGULAR SESSION JANUARY 8, 2024, SANGGUNIAN BARANGAY

WHEREAS, the public must realife that it is also their duty and responsibility to help keep surroundings clean and sanitary;

WHEREAS, Republic Act 9003, also known as the Solid Waste Acts, states that, for an ecological solid waste management program, creating the necessary institutional mechanism and incentives, declaring certain acts prohibited and providing penalties appropriating funds thereof and other purposes.

NOW THEREFORE, On motion of Hon. Arnie T. Lagumbay and duly seconded by Hon. Emma B. Sacapaño and all other members present, be it enacted by the Sanggunian Barangay in Session duly assembled that;


Section 1. Short Title, this ordinance shall be known and Cited as the "Anti-Littering ordinance in Barangay Sumadat, Dumalinao Zamboanga del Sur;

Section 2. Coverage. This ordinance shall cover the entire Barangay of Sumadat, Dumalinao Zamboanga del Sur.

Section 3. Definition of term: As Used in ordinance, the following term shall mean;

- 1. Barangay Office refers to the Seat of Local Government for Barangay
- 2. Business Establishments refers to an establishment where business are conducted, goods stored or processed or where service are rendered.
- 3. Children refers to a persons who is below 18 years of age.
- 4. Garbage Receptacles refers to containers, usually metal or plastics, used for disposals of waste matter:
- 5. Imbecile one who, while advance in age, has mental development comparable to that child between two to seven years of age.
- 6. Insane Persons refers to those individual who are completely deprived of intelligence in committing an act.
- 7. Solid Waste refers to any garbage, refuse, sludge from Waste water treatment plant, water supply treatment plant, or air pollution control fascility and other discarded materials.
- 8. Trash Can/Waste box referred to a covered or labelled container for temporarily storing waste and is usually made of metal and plastic.







BARANGAY SUMADAT

EXCERPTS FROM THE MINUTES 1st REGULAR SESSION JANUARY 8, 2024, SANGGUNIAN BARANGAY

Section 4. Regulated Acts.

- 1. It shall be unlawful for any person to throw away, litter or scatter cigarette butts, cellophanes, candy/bread wrappers, boxes/packages and other waste materials along streets, highways, sidewalks and other public places;
- 2. The following shall be required under this ordinance to make available trash bins or waste boxes in their establishment/ areas for proper waste disposals;
 - a. All business establishment
 - b. Fish, meat and Vegetable Vendors
 - c. Public utility vehicles such as jeepneys, Vans and tricycles.
 - d. Barangay offices

Section 5. Administrative Provisions.

- 1. A Task Force within barangay shall be created with the primary task of implementing this ordinance.
- 2. The Task Force shall recommend measures for the proper and efficient enforcement of this Ordinance.
- 3. The Task Force shall be headed by the following
 - The Punong Barangay, Committee of Environment, Committee on Health and all Barangay Health Worker and all Barangay Tanods as members.
- 4. The Barangay shall provide the violation tickets devised by the Municipal Environment and National Resources office for apprehension purposes.
- 5. In the event that the violator is apprehended the fine shall be accrued to the general fund and the income derived shall be utilized for green and clean programs and projects.
- 6. The Task Force shall conduct regular inspection and monitoring to assure effective implementation of the ordinance.
- 7. The Task Force shall conduct a seminar on proper waste disposal management and the littering of minors.

Section 6. Exception – The following persons shall be exempted from the provisions of this ordinance.

- 1. Insane persons
- 2. Imbecile
- 3. Children who are below 9 years of age
- 6.1. In case violations committed by children below 18 years of age, the parents, guardians or wards shall be held responsible for their acts. The parents, guardians or

as exercising Parenta authority shall be dealt accordingly under Section 7 hereof and the parents, guardians shall undergo counseling / seminar. Parents of Insane

persons, imbeciles, or children who are below 9 years old are exempted from the imposition of penalty.

Section 7. *Penalty* – any Persons found violating any provision of Ordinance shall be meted with the following penalties.

- <u>First Offense</u> a fine of Two Hundred Pesos (P200.00)
- Second offense- a fine of Three Hundred Pesos (P300.00)
- Third offense a fine of Five Hundred Pesos (P500.00)

Section 8. Repealing Clause.

All ordinance, resolutions executive issuances or rules and regulation or part thereof. Whose provisions are inconsistent with or contrary to the provision of this Ordinance, are hereby deemed repeated, amended or modified accordingly,

Section 9. Applicability clause,

The provisions of existing ordinance, resolutions or executive orders dealing with related subject matters, which are not contradictory with this ordinance, are hereby adopted as an integral part of this ordinance.

Section 10. Separable Clause.

If any reason, any section or provision of this ordinance is held unconstitutional or invalid, the other section or provisions hereof shall not be affected thereby.

Section 11. Effectivity.

This Ordinance shall take effect its approval and compliance with the Posting and publications requirements.
