**INTERPOSING NO OBJECTION FOR THE LAUNCHING OF LEVEL-3 WATER TREATMENT FACILITY OF JE HYDRO & BIO-ENERGY CORP. IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.**

**WHEREAS**, presented for consideration and appropriate action is the earnest intention of JE Hydro & Bio-energy Corp. to launch the JE Hydro Level-3 Water Supply Program in the locality;

**WHEREAS**, Section 447 (a), (4) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Bayan as the legislative body of the municipality, shall regulate activities relative to the use of land, buildings and structures within the municipality in order to promote the general welfare;

**WHEREAS**, JE Hydro & Bio-Energy Corp. has proposed to establish a Level-3 Water Treatment Facility in the Municipality of Dumalinao, Zamboanga del Sur, with the aim of providing safe, reliable, and high-quality water to the residents of the municipality;

**WHEREAS**, the proposed facility is expected to significantly improve the water supply system in Dumalinao, thereby promoting public health and enhancing the overall quality of life for the local community;

**WHEREAS**, the proposed establishment of the Level-3 Water Treatment Facility by JE Hydro & Bio-Energy Corp aligns with the municipality's development goals and is in the best interest of its residents;

With the continuous increase in population and the anticipated influx of investments in the Municipality of Dumalinao, the existing water systems are no longer sufficient to serve our entire populace. Issues such as low connectivity, water potability, and overall water quality are prevalent and need immediate attention.

Recognizing our Administration's commitment to addressing these water supply issues, JE Hydro & Bio-Energy Corporation (JE Hydro) has expressed a strong intent to launch the "JE Hydro Level-3 Water Supply Program" in our Municipality. Their proposal includes financing, developing, building, operating, and maintaining a state-of-the-art Water Treatment Facility that will provide ready-to-drink treated water meeting the specifications of the Philippine National Standard for Drinking Water to every household.

Key features of this project include:

1. Direct connection of brand-new pipes to homes without any charges related to "Water Connection Fees".
2. No imposition of "minimum charges" or "maximum charges".
3. A water tariff approved by a Certificate of Public Convenience (CPC) from the National Water Resources Board (NWRB), fixed at Five (5) Centavos per liter or One (1) Peso per 20L container. This is significantly cheaper than the water sold at many refilling stations at Twenty-Five (25) Pesos per 20L container.

Given these benefits, we believe that this project will greatly improve our Municipality's water supply system and overall quality of life. Therefore, we respectfully request a Resolution Interposing No Objection from the Sangguniang Bayan for JE Hydro's earnest intention to undertake the water distribution in the Municipality of Dumalinao.

We look forward to your favorable response and to the successful implementation of this vital project.

Our Company will finance, develop, build, operate and maintain a state-of-the-art Water Treatment Facility that will bring ready to drink treated water that meets the specification of the Philippine National Standard for Drinking Water to every household.

Our brand-new pipes will connect directly to homes without any charges related to "Water Connection Fees". We will not also impose "minimum charges" nor "maximum charges".

Our water tariff is covered by an approved Certificate of Public Convenience ("CPC") from the National Water Resources Board ("NWRB"). It will be fixed at Five (5) Centavos per liter or One (1) Peso per 20L container, which is very much cheaper than the water being sold in many refilling stations at Twenty-Five (25) Pesos per 20L container.

In this regard, we are respectfully submitting this request for a Resolution Interposing No Objection from the Sangguniang Bayan through your Honorable Office for the earnest intention of JE Hydro to do the water distribution in the Municipality of Dumalinao.
