RESOLUTION NO. 0371-2024

AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLO R. S. CERILLES, RMT, MAGD TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT ON BEHALF OF THE LOCAL GOVERNMENT OF DUMALINAO WITH THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA), REGION IX, REPRESENTED BY ITS REGIONAL DIRECTOR, DAN M. NAVARRO FOR THE IMPLEMENTATION OF TECHNICAL-VOCATIONAL EDUCATION AND TRAINING (TVET) PROGRAM IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the request of the Municipal Planning and Development Coordinator to authorize the Local Chief Executive to enter and sign a MOA with TESDA-IX for the implementation of TVET Program in the locality;

WHEREAS, Section 22 (c) of R.A 7160, otherwise known as the Local Government Code of 1991, provides, that every local government unit, as a corporation, shall, unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof,



which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the LGU-Dumalinao recognizes the importance of providing its constituents with opportunities for skills development and training to enhance their employability and productivity;

WHEREAS, the TESDA is mandated to promote and implement technical-vocational education and training (TVET) programs that will provide skills and competencies for gainful employment and sustainable livelihood;

WHEREAS, the partnership will involve joint efforts in the delivery of TVET programs, including but not limited to, the provision of technical-vocational training, assessment and certification, program monitoring and evaluation, and resource sharing between TESDA Region IX and the Local Government of Dumalinao;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. RHOLLY A. LABANG**, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junafior S. Cerilles, RMT, MAGD to enter and sign a Memorandum of Agreement on behalf of the Local Government of Dumalinao with the Technical Education and Skills Development Authority (TESDA), Region IX, represented by its Regional Director, Dan M. Navarro for the implementation of Technical-Vocational Education and Training (TVET) Program in the Municipality of Dumalinao, Zamboanga del Sur.

LET the copy of this resolution be furnished to concern offices and/or officials for reference, guidance, and appropriate action.

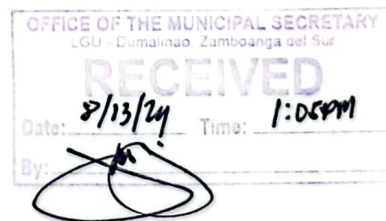

MEMORANDUM OF AGREEMENT

TRAINING in DRIVING NC II and CONSTRUCTION SKILLS for the Beneficiaries of DUMALINAO, Zamboanga del Sur

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement (the "MOA") is made and entered into by and between:

The **TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA)**, **Region IX**, located at the Provincial Capitol Compound, Sto. Niño, Pagadian City, represented by the Regional Director, **DAN M. NAVARRO**, for its implementing units under this MOA, the **TESDA Provincial Office of Zamboanga del Sur**, and the **Provincial Training Center – Pagadian** hereinafter referred to as the "**FIRST PARTY**"

-and-

The **MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR**, a Local Government Unit (LGU) duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal address at Barangay Pag-asa, Dumalinao, Zamboanga del Sur, represented for this Agreement, pursuant to Sangguniang Bayan Resolution No. _____, approved and adopted dated _____, by its elected Municipal Mayor, **HON. JUNAFLO R. CERILLES, RMT, MAGD**, hereinafter referred to as the "**SECOND PARTY**";

WITNESSETH THAT:

Whereas, the **TESDA** is mandated by law to provide relevant, accessible, high quality and efficient technical education and skills development in support to the development of high-quality middle-level manpower responsive to and in accordance with Philippine development goals and priorities;

Whereas, the **TESDA** supports partnership agreements with other government agencies and organizations and recognizes the active participation of various stakeholders in technical education and skills development;

Whereas, the **TESDA** through its Zamboanga del Sur Provincial Office and specifically, the Provincial Training Center – Pagadian City, gives flesh to TESDA's mandate to provide relevant, high quality and efficient technical education and skills development, making TESDA Abot Lahat;

Whereas, the Municipality of Dumalinao, Zamboanga del Sur, through its Local Youth Development Office made representation before the TESDA Zamboanga del Sur Provincial Office for the conduct of training to the youth beneficiaries of Dumalinao, ZDS, particularly in Driving NC II, Construction Painting NC II, Masonry NC II, and Plumbing NC II as a means of providing alternative means of livelihood to the beneficiaries;

Whereas, the Municipality of Dumalinao offers its facility – building, driving area, driving vehicle that will serve as "**OFF CAMPUS FACILITY**" to be used by the Provincial Training Center in the conduct of the training;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby mutually agree to the following:

I. COVENANT OF THE PARTIES:

A. FIRST PARTY shall:

1. Through the Provincial Training Center-Pagadian:

- a. Conduct two (2) batches of Training in Driving NC II, Construction Painting NC II, Masonry NC II, and Plumbing NC II for the youth beneficiaries
- b. Conduct the pre-training process such as Profiling and Training Induction Program (TIP).
- c. Provide Accredited Trainer in Driving NC II, Construction Painting NC II, Masonry NC II, and Plumbing NC II.
- d. Assist the beneficiaries in their application for National Assessment.

2. Through the TESDA Zamboanga del Sur Provincial Office:

- a. Monitor the conduct of training and ensure compliance to UTPRAS Requirements under the Mobile Training Program (MTP).
- b. Schedule the conduct of Competency Assessment to qualified beneficiaries.
- c. Provide free National Certificates to the beneficiaries that pass the National Assessment.

B. SECOND PARTY shall:

1. Identify qualified beneficiaries to the Training Program.
2. Provide the training venue with provision for electricity and water, driving range safe for driving practices, driving vehicle, fuel and other amenities including assistance in accommodating the Trainer.
3. Shoulder the prescribed Assessment Fee of P819.00 per candidate for the beneficiaries qualified to undertake the national assessment.
4. Ferry the trainees to the Assessment Center for the conduct of National Assessment.

II. AMENDMENTS

The parties hereto, upon mutual consent, amend or modify this Agreement or through a written addendum duly signed by them.

III. EFFECTIVITY

This agreement shall take effect immediately upon approval and signing by the contracting parties and shall remain in full force and effect until the Training has been completed and reported in the year 2024 unless terminated by any of the parties hereto upon written notice to the other.
