RESOLUTION NO. 0374-2024

RESPECTFULLY REQUESTING THE HONORABLE SENATOR FRANCIS N. "TOL" TOLENTINO OF THE REPUBLIC OF THE PHILIPPINES TO ALLOCATE FUNDS FOR THE PROPOSED HOUSING PROJECT FOR INDIGENOUS PEOPLES OF THE MUNICIPALITY OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila, Indigenous People Mandatory Representative of Dumalinao to respectfully request the Honorable Senator Francis N. "Tol" Tolentino of the Republic of the Philippines to allocate funds for the proposed Housing Project for Indigenous Peoples of the Municipality Dumalinao, Province of Zamboanga del Sur;

WHEREAS, it is a Constitutional mandate of the State to recognize and promote the rights of indigenous cultural communities within the framework of national unity and development;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;



WHEREAS, the Municipality of Dumalinao is a 4th class municipality in the Province of Zamboanga del Sur, which is politically subdivided into 30 barangays with an estimated population of 32, 013;

WHEREAS, there are more than 5 000 Indigenous Peoples residing and at the same time, developing, and preserving their culture, customs, and traditions in the locality who are longing for their own dream houses for their families in order to have a shelter and a safe home to be with;

WHEREAS, the IPMR of Dumalinao has proposed a well-structured House and Lot Project that aims to acquire suitable land and construct housing units specifically designed to meet the cultural and traditional preferences of the indigenous community in the locality;

WHEREAS, this housing project will not only improve the living conditions of the indigenous people but also promote cultural preservation and social cohesion within the community;

WHEREAS, considering the limited resources of the Local Government Unit of Dumalinao, this august body deemed it necessary to source out funds, hence to ask to the good Senator Francis N. "Tol" Tolentino for financial support;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. ROMEO D. PARILA**, the body resolved, as it hereby resolves to respectfully requesting the Honorable Senator Francis N. "Tol" Tolentino of the Republic of the Philippines to allocate funds for the proposed Housing Project for Indigenous Peoples of Municipality of Dumalinao, Province of Zamboanga del Sur.
