RESPECTFULLY ASKING THE REGIONAL EXECUTIVE DIRECTOR, ENGR. MARCOS C. AVES, SR., OF THE DEPARTMENT OF AGRICULTURE, REGION IX, TO PROVIDE ASSORTED AGRICULTURE SEEDS AND OTHER AGRICULTURAL SUPPLIES FOR THE INDIGENOUS PEOPLES DAY CELEBRATION ON OCTOBER 28, 2024, AT THE MUNICIPAL GYMNASIUM OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila to respectfully ask the Regional Director, Engr. Marcos C. Aves, Sr., of the Department of Agriculture, Region IX, to provide assorted agriculture seeds and other agricultural supplies for the IP Day celebration on October 28, 2024, at the Municipal Gymnasium of Dumalinao;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;
