#### **RESOLUTION NO. 0376-2024**

ADOPTING THE GUIDELINES ON THE DELIVERY OF BASIC HEALTH SERVICES FOR INDIGENOUS CULTURAL COMMUNITIES/INDIGENOUS PEOPLES IN THE LOCAL GOVERNMENT UNIT OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR PURSUANT TO DOH-NCIP-DILG JOINT MEMORANDUM CIRCULAR NO. 2013-01 DATED APRIL 19, 2013.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila to adopt the Guidelines on the Delivery of Basic Health Services for Indigenous Cultural Communities/Indigenous Peoples in the LGU-Dumalinao pursuant to DOH-NCIP-DILG Joint Memorandum Circular No. 2013-01 dated April 19, 2013;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the Department of Health (DOH), the National Commission on Indigenous Peoples (NCIP), and the Department of the Interior and Local Government (DILG) have jointly issued Memorandum Circular No. 2013-01 dated



April 19, 2013, which provides the guidelines for the delivery of basic health services to Indigenous Cultural Communities/Indigenous Peoples (ICCs/IPs)

WHEREAS, the said guidelines aim to ensure that ICCs/IPs have access to basic health services that are culturally sensitive, appropriate, and inclusive, and to enhance the capacity of Local Government Units to deliver such services;

WHEREAS, the LGU-Dumalinao recognizes the rights of ICCs/IPs to be provided with adequate health care that is accessible, available, acceptable, and of quality, in accordance with their customs, traditions, and cultural beliefs;

WHEREAS, the LGU-Dumalinao, in support of the DOH-NCIP-DILG Joint Memorandum Circular No. 2013-01, seeks to adopt these guidelines to improve the delivery of basic health services to ICCs/IPs in the municipality, ensuring their right to health is upheld;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. ROMEO D. PARILA, the body resolved, as it hereby resolves to adopt the Guidelines on the Delivery of Basic Health Services for Indigenous Cultural Communities/Indigenous Peoples in the Local Government Unit of Dumalinao, Province of Zamboanga del Sur pursuant to DOH-NCIP-DILG Joint Memorandum Circular No. 2013-01 dated April 19, 2013.
