#### **RESOLUTION NO. 0377-2024**

FAVORABLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, THROUGH THE OFFICE OF THE MUNICIPAL ENGINEERING TO CONDUCT AN OCULAR INSPECTION OF THE MUNICIPAL ROAD BESIDE KREMA RESTAURANT GOING TO DUMALINAO REGIONAL PILOT SCHOOL, BARANGAY PAGLAUM, DUMALINAO, ZAMBOANGA DEL SUR.

**WHEREAS**, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra to favorably request the Local Chief Executive through the Office of the Municipal Engineering to conduct an ocular inspection of the Municipal Road beside Krima Restaurant going to DRPS, Barangay Paglaum, Dumalinao, Zamboanga del Sur;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS,** it is the duty of the Local Government Unit of Dumalinao to ensure the safety and accessibility of public roads within its jurisdiction;



WHEREAS, it has come to the attention of the Municipal Council that several houses have been constructed along the Municipal Road beside Krema Restaurant going to DRPS, Barangay Paglaum, Dumalinao, Zamboanga del Sur;

WHEREAS, it appears that these constructions may have violated the existing Zoning Ordinance of the municipality, potentially causing inconvenience and safety hazards for the community:

WHEREAS, it is imperative to ensure that all constructions within the municipality comply with the Zoning Ordinance to promote orderly development, safety, and the general welfare of the residents;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order:

THEREFORE, premises above-considered, on motion by HON. FREDERICK R. BALANDRA, the body resolved, as it hereby resolves to favorably request the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, through the Office of the Municipal Engineering to conduct an ocular inspection of the Municipal Road beside Krema Restaurant going to Dumalinao Regional Pilot School (DRPS), Barangay Paglaum, Dumalinao, Province of Zamboanga del Sur.
