WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila to respectfully request the Provincial Director of DTI-Zamboanga del Sur, to conduct Sweet Potato Chips Skills Training and/or Herbal Coffee Making to IP of Barangay Camalig as part of the celebration of Indigenous Peoples Day on October 17, 2024;
