FAVORABLY REQUESTING THE LOCAL CHIEF EXECUITVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, THROUGH THE OFFICE OF THE MUNICIPAL ENVIRONMENTAL AND NATURAL RESOURCES (MENRO) TO PROVIDE TREE SEEDLINGS TO INDIGENOUS PEOPLES TREE GROWING ACTIVITY ON OCTOBER 27, 2024 AS PART OF THE CELEBRATION OF INDIGENOUS PEOPLES DAY OF THE MUNICIPALITY OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila to favorably request the Local Chief Executive through the Office of the Municipal Environment and Natural Resources to provide tree seedlings to IP Tree Growing Activity on October 27, 2024 as part of the celebration of IP Day of the locality;

WHEREAS, it is a Constitutional mandate of the State to recognize and promote the rights of indigenous cultural communities within the framework of national unity and development;

WHEREAS, Section 447, (a), (5) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan as the legislative body of the municipality, shall pass resolutions to ensure the efficient and effective delivery of the basic services and facilities as provided under Section 17 of this Code;





WHEREAS, on October 28, 2024, marks the celebration of Indigenous Peoples Day in the Municipality of Dumalinao, Province of Zamboanga del Sur, to honor the IPs' rich cultural traditions and their important role in environmental conservation;

WHEREAS, part of the celebration of Indigenous Peoples Day is a tree-growing activity on October 27, 2024, that aims to promote environmental sustainability and strengthen the partnership between the Local Government of Dumalinao and the Indigenous Peoples community;

WHEREAS, in line with the Municipality's commitment to environmental protection and sustainable development, it is necessary to support this initiative by providing tree seedlings to ensure the success of the said activity;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. ROMEO D. PARILA, the body resolved, as it hereby resolves to favorably requesting the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, through the Office of the Municipal Environmental and Natural Resources (MENRO) to provide tree seedlings to Indigenous Peoples Tree Growing Activity on October 27, 2024 as part of the celebration of Indigenous Peoples Day of the Municipality of Dumalinao, Province of Zamboanga del Sur.
