

RESPECTFULLY REQUESTING THE BETINAN RESEARCH STATION (BRS) OF THE MUNICIPALITY OF SAN MIGUEL TO CONDUCT TRAINING ON MUSHROOM PRODUCTION FOR INDIGENOUS PEOPLES OF BARANGAY REBOKON, MUNICIPALITY OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR, ON OCTOBER 26-27, 2024, AT THE 2ND-FLOOR BUILDING, **DUMALINAO FUNCTION HALL.** 

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila to respectfully request the Betinan Research Station (BRS) of the Municipality of San Miguel to conduct training on Mushroom Production to IP of Barangay Rebokon on October 26-27, 2024, at the 2nd-floor building, Dumalinao Function Hall;

WHEREAS, it is a Constitutional mandate of the State to recognize and promote the rights of indigenous cultural communities within the framework of national unity and development:

WHEREAS, the Betinan Research Station (BRS) of the Municipality of San Miguel is well-equipped with the expertise and resources necessary to provide comprehensive training on mushroom production, which can greatly benefit the Indigenous Peoples of Barangay Rebokon;

WHEREAS, part of the celebration of Indigenous Peoples Day is a training on Mushroom Production on October 26-27, 2024, that aims to empower the Indigenous Peoples of Barangay Rebokon with new knowledge, techniques, and strategies in mushroom production, potentially creating new sources of livelihood for the community;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;


