**RESOLUTION NO. 0402-2024**

**ADOPTING THE APPROVED PLANS AND BUDGETS FOR CALENDAR YEAR 2025, OF THE DIFFERENT LOCAL SPECIAL BODIES (LSB) OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR, TO WIT: 1. GENDER AND DEVELOPMENT (GAD); 2. LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC); 3. SENIOR CITIZEN (SC); 4. PERSON WITH DISABILITY (PWD); 5. MUNICIPAL NUTRITION ACTION PLAN; 6. PEACE AND ORDER AND PUBLIC SAFETY (POPS); AND 7. LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (LDRRMFIP).**

**WHEREAS**, presented for consideration and appropriate action are the approved plans and budgets for CY 2025 of the different LSB of LGU-Dumalinao, to wit: 1. GAD Plan and Budget; 2. LCPC Plan and Budget; 3. SC Plan and Budget; 4. PWD Plan and Budget; 5. MNA Plan and Budget; 6. POPS Plan and Budget; and 7. LDRRMFI Plan and Budget for adoption of this August body;

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise powers expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, the programs, projects, and activities of the following plans and budgets for Calendar Year 2025 mentioned above, have been duly reviewed, deliberated upon, and approved by the concerned Local Special Bodies (LSB);





**WHEREAS**, the approved plans and budgets are aligned with the municipality's development goals and strategic priorities, and their implementation will contribute significantly to the welfare and development of the citizens of Dumalinao;

**WHEREAS**, the August body finds that the said plans and budgets to be comprehensive, appropriate, and responsive to the needs of their respective sectors;

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**NOW THEREFORE**, premises above-considered, on motion by **HON. HERMES B. CABALES**, duly seconded by **HON. JELITO R. PEÑONAL**, it was resolved, as it is hereby resolved, to adopt the approved plans and budgets for Calendar Year 2025, of the different Local Special Bodies (LSB) of the Local Government Unit of Dumalinao, Province of Zamboanga del Sur, to wit: 1. Gender and Development (GAD); 2. Local Council for the Protection of Children (LCPC); 3. Senior Citizen (SC); 4. Person with Disability (PWD); 5. Municipal Nutrition Action Plan; 6. Peace and Order and Public Safety (POPS); and 7. Local Disaster Risk Reduction And Management Fund Investment Plan (LDRRMFIP).

**RESOLVED FURTHER**, that the Municipal Mayor and the concerned departments and offices are hereby directed to ensure the proper implementation of the said plans and budgets in accordance with applicable laws, rules, and regulations.

**LET** that copy of this resolution be furnished to all concerned Local Special Bodies (LSB), the Municipal Mayor, and other relevant offices for their information, guidance, and appropriate action.


