RESOLUTION NO. 0415-2025

RESPECTFULLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD TO PROVIDE KASAMBAHAY HELP DESK IN THE MUNICIPALITY OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR IN ACCORDANCE WITH REPUBLIC ACT NO. 10361, OTHERWISE KNOWN AS THE DOMESTIC WORKERS ACT OR BATAS KASAMBAHAY AND ENJOINING THE BARANGAY LOCAL GOVERNMENT UNIT OFFICIALS TO DO THE SAME IN THEIR RESPECTIVE JURISDICTION.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Joel L. Famor to respectfully request the Local Chief Executive to provide Kasambahay Help Desk in the municipality in accordance with R.A No. 10361, otherwise known as the Domestic Workers Act or Batas Kasambahay and enjoining the BLGU Officials to do the same in their respective jurisdiction;

WHEREAS, Section 447, (a), (5) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan as the legislative body of the municipality, shall pass resolutions to ensure the efficient and effective delivery of the basic services and facilities as provided under Section 17 of this Code;

WHEREAS, Republic Act No. 10361, otherwise known as the "Domestic Workers Act" or "Batas Kasambahay," and the Department of Interior and Local Government Memorandum Circular No. 2022-100, mandates the local government units to implement programs and initiatives that promote the



welfare of domestic workers, including the establishment of a system to monitor and address their concerns;

WHEREAS, a Kasambahay Help Desk will serve as a dedicated mechanism for receiving and addressing complaints, inquiries, and concerns of domestic workers, as well as providing them with necessary legal, social, and livelihood assistance;

WHEREAS, the Barangay Local Government Unit play a crucial role in the implementation of the law at the grassroots level and are encouraged to establish similar desks in their respective barangays to provide immediate assistance to domestic workers within their jurisdiction;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW THEREFORE, premises above-considered, on motion by **HON. JOEL L. FAMOR**, and duly severally seconded by the August body, it was resolved, as it is hereby resolved, to respectfully request the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to provide Kasambahay Help Desk in the Municipality of Dumalinao, Province of Zamboanga del Sur in accordance with Republic Act No. 10361, otherwise known as the Domestic Workers Act or Batas Kasambahay and enjoining the Barangay Local Government Unit Officials to do the same in their respective jurisdiction.


