

RESOLUTION NO. 058-2022

RESPECTFULLY REQUESTING THE MUNICIPAL MAYOR, HONORABLE JUNAFLOR S. CERILLES, RMT, MAGD, TO SUSPEND THE FILLING-UP OF VACANT POSITIONS/ITEMS. PROMOTIONS, AND CREATION OF NEW POSITION IN THE LOCAL GOVERNMENT UNIT OF DUMALINAO TO SUPPORT THE RE-CLASSIFICATION OF CLASS OF THE MUNICIPALITY.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabales to request the Municipal Mayor, Honorable Junaflor S. Cerilles, RMT, MAGD, to suspend the filling-up of vacant positions/items, promotions, and creation of the new position in the Local Government Unit of Dumalinao to support the reclassification of class of the municipality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare:

WHEREAS, the re-classification process will enable the LGU to be more advantageous in the determination of financial capability for projects, applications, grants, salary increases, and wages, and more viable to investments and employment opportunities, especially in the implementation of Mandanas ruling;

WHEREAS, the Local Government Unit of Dumalinao, for the last three (3) calendar years of its Average Annual Income, is qualified to apply re-classification from 4th class to 3rd class municipality;

WHEREAS, the suspension of filling-up of vacant positions/items, promotions, and creation of the new position in the Local Government Unit of Dumalinao is a preparatory requirement for the application of re-classification of class in the locality;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. HERMES B. CABALES the body resolved, as it hereby resolves to request the Municipal Mayor, Honorable Junaflor S. Cerilles, RMT, MAGD, to suspend the filling-up of vacant positions/items, promotions, and creation of the new position in the Local Government Unit of Dumalinao to support the reclassification of class of the municipality.
