### **RESOLUTION NO. 060-2022**

REQUIRING ALL BARANGAY INDIGENOUS PEOPLE MANDATORY REPRESENTATIVE (IPMR) IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR, TO ESTABLISH NURSERY HOUSE FOR PLANT PROPAGATION PROGRAM.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila to require all Barangay Indigenous People Mandatory Representatives (IPMR) in the Municipality of Dumalinao, Zamboanga del Sur, to establish a nursery house for the plant propagation program;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the Local Government Unit of Dumalinao ensures to deliver of general welfare services, particularly in the environment and natural resources management in the locality;







WHEREAS, the establishment of Nursery House is a mechanism for promoting and attaining ecological balance for a healthy environment, not only for the people but also for the future generation;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;
