RESOLUTION NO. 067-2022

HUMBLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLORES S. CERILLES, RMT, MAGD, TO REQUEST THE LAND TRANSPORTATION OFFICE (LTO) REGION IX, TO CONDUCT TRAINING AND SEMINAR TO DEPUTIZE THE LOCAL GOVERNMENT UNIT TRAFFIC ENFORCER OF DUMALINAO TO FULLY ENFORCE THE ARTICLE N OF THE MUNICIPAL ORDINANCE NO. 2020-03-441 AND IN CONFORMITY TO THE DILG-DOTC JOINT MEMORANDUM CIRCULAR (JMC) NO. 1, S., 2008.

WHEREAS, presented for consideration and appropriate action, is the proposed resolution of Hon. Jelito R. Peñonal to request the Local Chief Executive to request the Land Transportation Office (LTO), Region IX, to conduct training and seminar to deputize the local government unit traffic enforcer of Dumalinao to fully enforce the Article N of the Municipal Ordinance No. 2020-03-441 and in conformity to the DILG-DOTC Joint Memorandum Circular (JMC) No. 01, S., 2008;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective



governance, and those which are essential to the promotion of the general welfare;

WHEREAS, under Section 17 of the above Code, mandates the Local Government Units to exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities;

WHEREAS, Article N of the Municipal Ordinance No. 2020-03-441, dated March 9, 2020, provides Rules and Regulations Governing Vehicular Traffic and Use of Thoroughfares are declared Traffic Violations;

WHEREAS, according to 3.4 of DILG-DOTC Joint Memorandum Circular (JMC) No. 01, S., 2008, on the issuance of traffic citation tickets, states that the LGUs can issue traffic citation tickets, but only the LTO and their deputized agents can confiscate drivers' licenses;

WHEREAS, the august body finds that it is necessary to deputize the Local Traffic Enforcer of Dumalinao by the Land Transportation Office, Region IX, in order to fully enforce the Article N of the Municipal Ordinance No. 2020-03-441 and to conform to DILG-DOTC Joint Memorandum Circular (JMC) No. 01, S., 2008;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. JELITO R. PEÑONAL**, the body resolved, as it hereby resolves to request the Local Chief Executive, Honorable Mayor Junafior S. Cerilles, RMT, MAGD, to request the Land Transportation Office (LTO), Region IX, to conduct training and seminar to deputize the local government unit traffic enforcer of Dumalinao to fully enforce the Article N of the Municipal Ordinance No. 2020-03-441 and in conformity to the DILG-DOTC Joint Memorandum Circular (JMC) No. 01, S., 2008.
