## **RESOLUTION NO. 068-2022**

STRONGLY SUPPORT THE LIGA NG MGA BARANGAY RESOLUTION NO. 001-2022 OF DUMALINAO, ZAMBOANGA DEL SUR, REQUESTING THE GOVENOR OF ZAMBOANGA DEL SUR, HONORABLE VICTOR J. YU TO ALLOCATE FUNDS FOR THE REPAIR AND REHABILITATION OF BAGA-PANTAD CEMETERY ROAD IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action, is the LIGA ng mga Barangay Resolution No. 001-2022, requesting the Governor of Zamboanga del Sur, Honorable Victor J. Yu to allocate funds for the repair and rehabilitation of Baga-Pantad Cemetery road in the locality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;





WHEREAS, under Section 17 of the above Code, mandates the Local Government Units to exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities;

WHEREAS, the Baga-Pantad cemetery road has not been passable for quite numbers of years which the seven (7) or more barangays previously used and now deprived by the use of the said cemetery;

WHEREAS, considering the limited resources of the LGU, this august body deemed it necessary to source out funds, hence to appeal to the good Governor, Honorable Victor J. Yu, for financial assistance;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON.HERMES B. CABALES, the body resolved, as it hereby resolves to support the LIGA ng mga Barangay Resolution No. 001-2022, requesting the Governor of Zamboanga del Sur, Honorable Victor J. Yu to allocate funds for the repair and rehabilitation of Baga-Pantad Cemetery road in the Municipality of Dumalinao, Zamboanga del Sur.
