### **RESOLUTION NO. 075-2022**

RESPECTFULLY ENDORSING TO THE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES. HIS EXCELLENCY FERDINAND R. MARCOS, JR., THROUGH UNDERSECRETARY RAYMUND B. FERRER, ADMINISTRATOR OF THE OFFICE OF THE CIVIL DEFENSE (OCD) AND EXECUTIVE DIRECTOR OF THE NATIONAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL THE REQUEST OF THE HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO ALLOCATE FUNDING ASSISTANCE FOR THE CONSTRUCTION OF THE FLOOD CONTROL SYSTEM PROJECT AT BARANGAY SUMADAT, DUMALINAO, ZAMBOANGA DEL SUR, AMOUNTING TO ONE HUNDRED MILLION PESOS (PHP100, 000, 000.00) FROM THE AVAILABLE FUND OF THE NATIONAL DISASTER RICK REDUCTION MANAGEMENT (NDRRM).

WHEREAS, presented for consideration and appropriate action is the request of the Local Chief Executive to endorse her request to the President of the Republic of the Philippines through Undersecretary of the Office of the Civil Defense and Executive Director of National Disaster Risk Reduction and Management Council to allocate funding assistance for the construction of the Flood Control System Project at Barangay Sumadat, Dumalinao, Zamboanga del Sur, amounting to





One Hundred Million Pesos (Php100, 000, 000.00) from the available fund of NDRRM;

WHEREAS, Section 17 (b) (2) (viii) of the Local Government Code of 1991, states that the LGU shall provide services and facilities include, but are not limited to infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including, but not limited to, municipal roads and bridges; school building and other facilities for elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring development, rainwater collectors and water supply system; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities, as part of the basic services devolved to the municipalities;

WHEREAS, the Municipality of Dumalinao is a 4th class municipality in the Province of Zamboanga del Sur, which is politically subdivided into 30 barangays with an estimated population of 32, 013;

WHEREAS, flooding, siltation, and erosion have been perennial problems in this municipality that continuously pose a danger to the lives and properties of the inhabitants, and its massive destruction from this detrimental effect shall be swiftly and effectively addressed;

**WHEREAS**, the construction of the Flood Control System Project will boost not only the safety and resiliency of the surrounding communities but also to disaster preparedness and mitigation;

WHEREAS, considering the limited resources of the LGU, this august body deemed it necessary to source out funds, hence to appeal to the President of the Republic of the Philippines, His Excellency Ferdinand R. Marcos, Jr., through Undersecretary Raymund B. Ferrer, Administrator of the Office of the Civil Defense and Executive Director of National Disaster Risk Reduction and Management Council, for financial assistance:

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. JESSIE NIEL C. PAULO the body resolved, as it hereby resolves to endorse to the President of the Republic of the Philippines, His Excellency Ferdinand R. Marcos, Jr., through Undersecretary Raymund B. Ferrer, Administrator of the Office of the Civil Defense and Executive Director of National Disaster Risk Reduction and Management Council, the request of Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to allocate funding assistance for the construction of Flood Control System Project at Barangay Sumadat, Dumalinao, Zamboanga del Sur, amounting to One Hundred Million Pesos (Php100, 000, 000.00) from the available fund of National Disaster Rick Reduction Management (NDRRM).
