### RESOLUTION NO. 080-2022

AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE JUNAFLOR S. CERILLES, RMT. MAGD. TO PURCHASE LOT FOR ALL PURPOSES, DEEM PROPER, LEGAL AND IN ORDER IN FAVOR OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabales to authorize the Local Chief Executive to purchase lot for all purposes, deem proper, legal and in order in favor of the Local Government Unit of Dumalinao, Zamboanga del Sur;

WHEREAS, Section 22 of R.A 7160, otherwise known as the Local Government Code of 1991, provides that the local government units shall have the power and authority to acquire, develop, lease, encumber, alienate, or otherwise dispose of real or personal property held by them in their proprietary capacity;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds,

contracts, obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Local Government Unit of Dumalinao allocated a budget to purchase lot/land in favor of the LGU:

WHEREAS, the LGU-Dumalinao needs lot/land to be place and use for government projects for public purposes to provide basic services and facilities to the people of the locality;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. HERMES B. CABALES, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to purchase lot for all purposes, deem proper, legal and in order in favor of the Local Government Unit of Dumalinao, Zamboanga del Sur.
