RESOLUTION NO. 082-2022

HUMBLY REQUESTING THE OFFICE OF THE MUNICIPAL MAYOR AND THE MUNICIPAL ENGINEERING OFFICE TO CONDUCT AN INSPECTION IN THE SLAUGHTERHOUSE FACILITY OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR, AND TO TAKE APPROPRIATE ACTION THEREAT.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabales to request the Office of the Municipal Mayor and the Municipal Engineering Office to conduct an inspection in the Slaughterhouse facility of the Municipality of Dumalinao, Zamboanga del Sur, and to take appropriate action thereat;

WHEREAS, Section 17 of R.A 7160, otherwise known as the Local Government Code of 1991, provides that the local government units shall provide basic services and facilities to the people;

WHEREAS, the Dumalinao slaughterhouse is a facility owned and managed by the Local Government Unit of Dumalinao and one of the sources of economic enterprise which collects fees and charges where animals are slaughtered for human consumption;





WHEREAS, based on the report by the slaughterhouse master, the said facility has a poor drainage system, the septic tank was already full, and no condemned pit, which can affect the sanitation thereof;

WHEREAS, the august body finds it necessary to conduct an inspection and monitoring in the slaughterhouse facility;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. HERMES B. CABALES, the body resolved, as it hereby resolves to the Office of the Municipal Mayor and the Municipal Engineering Office to conduct an inspection in the Slaughterhouse facility of the Municipality of Dumalinao, Zamboanga del Sur, and to take appropriate action thereat.
