RESOLUTION NO. 085-2022

URGING THE DIFFERENT CONCERNED OFFICES TO SUBMIT THEIR RESPECTIVE PLANS AND BUDGET FOR CALENDAR YEAR 2023 TO THE OFFICE OF THE MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR AND SANGGUNIANG BAYAN, ON OR BEFORE NOVEMBER 4, 2022, FOR APPROVAL AND ADOPTION OTHERWISE, THE SAID PLANS AND BUDGET WILL NO LONGER ACCOMMODATED AND INCORPORATED IN THE ANNUAL BUDGET FOR CALENDAR YEAR 2023 OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the request of the Municipal Planning and Development Coordinator (MPDC) Officer to urge the different concerned offices to submit their respective plans and budget for CY 2023 to the Office of the MPDC and Sangguniang Bayan on or before November 4, 2022, for approval and adoption otherwise, the said plans and budget will no longer accommodated and incorporated in the Annual Budget for CY 2023 of the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, pursuant to Section 319 of Republic Act No. 7160 states that on or before the end of the current fiscal year, the Sanggunian concerned shall enact, through an ordinance, the annual budget of the local government unit for the



ensuing fiscal year on the basis of the estimates of income and expenditures submitted by the Local Chief Executive;

WHEREAS, the Executive Budget/Budget Message by the Local Chief Executive was already received by the Office of the Secretary to the Sanggunian last October 14, 2022, and immediately was referred to the Committee on Appropriation and Finance for review and appropriation action;

WHEREAS, the Sanggunian shall do the Budget Authorization through legislative discussion of the proposed Annual Budget between October 16 and November 17 of the current fiscal year;

WHEREAS, the different supporting documents for the enactment of the Annual Budget 2023 are the following plans, to wit: GAD Plan; LDRRM Plan; Climate Change Action Plan; POPS Plan; LCPC Plan; SC Plan; PWD Plan; and the MNC Plan and these plans shall be incorporated to the Annual Investment Plan of the locality;

WHEREAS, to date, the abovementioned plans have not yet been submitted to the MPDC for incorporation in the Annual Investment Plan (AIP), which the same shall be subject for adoption and approval of the Sanggunian Bayan;

WHEREAS, failure to enact and pass the approved Annual Budget for CY 2023 will result in the re-enactment of the Annual Budget in the preceding year;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. ARNOLD L. FLORES**, the body resolved, as it hereby resolves to urge the different concerned offices to submit their respective plans and budget for CY 2023 to the Office of the MPDC and Sangguniang Bayan on or before November 4, 2022, for approval and adoption otherwise, the said plans and budget will no longer accommodated and incorporated in the Annual Budget for CY 2023 of the Municipality of Dumalinao, Zamboanga del Sur.

LET the copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.
