RESOLUTION NO. 087-2022

STRONGLY SUPPORT THE JOINT RESOLUTION OF GENERAL PARENTS TEACHERS ASSOCIATION (GPTA) OF PANTAD ELEMENTARY SCHOOL AND BARANGAY PANTAD, MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR, TO REQUEST THE HONORABLE GOVERNOR VICTOR J. YU, TO ALLOCATE FUNDS FOR THE PROPOSED CONSTRUCTION OF COVERED COURT AND INSTALLATION OF WIFI CONNECTION AT PANTAD ELEMENTARY SCHOOL.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabales to support the Joint Resolution of GPTA of Pantad Elementary School and Barangay Pantad, Municipality of Dumalinao, Zamboanga del Sur, to request the Honorable Governor Victor J. Yu, to allocate fund for the proposed construction of covered court and installation of WIFI connection at Pantad Elementary School;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective

governance, and those which are essential to the promotion of the general welfare;

WHEREAS, under Section 17 of the above Code, mandates the Local Government Units to exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities;

WHEREAS, considering the limited resources of the LGU and Pantad Elementary School, this august body deemed it necessary to source out funds, hence to appeal to the good Governor, Honorable Victor J. Yu, for financial assistance;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. HERMES B. CABALES the body resolved, as it hereby resolves to support the Joint Resolution of GPTA of Pantad Elementary School and Barangay Pantad, Municipality of Dumalinao, Zamboanga del Sur, to request the Honorable Governor Victor J. Yu, to allocate fund for the proposed construction of covered court and installation of WIFI connection at Pantad Elementary School.
