RESOLUTION NO. 089-2022

RESPECTFULLY REQUESTING THE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, HIS EXCELLENCY FERDINAND R. MARCOS, JR., THROUGH SECRETARY AMENAH F. PANGANDAMAN, OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO ALLOCATE FUNDS FOR THE HOUSING PROGRAM OF INDIGENOUS PEOPLE OF **DUMALINAO, ZAMBOANGA DEL SUR.**

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila, Indigenous People Mandatory Representative of Dumalinao to request the President of the Republic of the Philippines, His Excellency Ferdinand R. Marcos, Jr., through the Department of Budget and Management (DBM) to allocate funds for the Housing Program of Indigenous People of Dumalinao, Zamboanga del Sur;

WHEREAS, Section 17 (b) (2) (viii) of the Local Government Code of 1991, states that the LGU shall provide services and facilities include, but are not limited to infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including, but not limited to, municipal roads and bridges; school building and other facilities for elementary and secondary schools; clinics, health centers and other health

facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring development, rainwater collectors and water supply system; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities, as part of the basic services devolved to the municipalities;

WHEREAS, the Municipality of Dumalinao is a 4th class municipality in the Province of Zamboanga del Sur, which is politically subdivided into 30 barangays with an estimated population of 32, 013;

WHEREAS, there are more than 5 000 estimated Indigenous People residing and preserving and at the same time developing their culture and tradition in the locality who are longing for their own dream houses for their families to have a shelter and a safe home to be with;

WHEREAS, considering the limited resources of the LGU, this august body deemed it necessary to source out funds, hence to appeal to the President of the Republic of the Philippines, His Excellency Ferdinand R. Marcos, Jr., through Department of Budget and Management (DBM), for financial assistance;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. ROMEO D. PARILA the body resolved, as it hereby resolves to request the President of the Republic of the Philippines, His Excellency Ferdinand R. Marcos, Jr., through Secretary Amenah F. Pangandaman of the Department of Budget and Management (DBM) to allocate funds for the Housing Program of Indigenous People of Dumalinao, Zamboanga del Sur.
