FAVORABLY ENDORSING THE SENIOR CITIZEN'S ASSOCIATION RESOLUTION NO. 001-2022, TO THE PROVINCIAL GOVERNOR OF THE PROVINCE OF ZAMBOANGA DEL SUR, HONORABLE VICTOR J. YU, TO ALLOCATE FUNDS FOR THE PROPOSED CONSTRUCTION OF SENIOR CITIZEN'S BUILDING AT BARANGAY PAGLAUM, DUMALINAO, ZAMBOANGA DEL SUR.
