

### **RESOLUTION NO. 0223-2023**

DECLARING OPERATIVE IN ITS ENTIRETY THE ANNUAL BUDGET OF SANGGUNIANG KABATAAN OF BARANGAY MOTOSAWA, DUMALINAO, ZAMBOANGA DEL SUR, FOR FISCAL YEAR 2023, AMOUNTING TO THREE HUNDRED TWO THOUSAND FIVE HUNDRED THIRTY-TWO PESOS AND SEVENTY CENTAVOS (PHP302, 532.70), SUBJECT TO ALL ACCOUNTING AND AUDITING RULES AND PROCEDURES.

WHEREAS, presented for consideration and appropriate action is the Annual Budget of Sangguniang Kabataan of Barangay Motosawa, Dumalinao, Zamboanga del Sur, for FY 2023, amounting to Three Hundred Two Thousand Five Hundred Thirty-Two Pesos and Seventy Centavos (Php302, 532.70);

WHEREAS, pursuant to Section 20 (a) of the SK Reform Act of 2015 Republic Act No.10742, ten percent (10%) of the general fund of the barangay shall be set aside for the Sangguniang Kabataan. The Sangguniang barangay shall appropriate the SK funds in lump-sum, which shall be disbursed solely for youth development and empowerment purposes;

WHEREAS, Sangguniang Kabataan Annual Budget for FY 2023 of Barangay Motosawa was thoroughly reviewed by the Committee on Finance, Budget, and Appropriation and found to be in order and had complied with all the budgetary





requirements of the Local Government Code of 1991 and its implementing rules and regulations and other laws, rules and regulations issued by the Department of Budget and Management;

**WHEREAS,** after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. ARNOLD L. FLORES the body resolved, as it hereby resolves to declare operative in its entirety the Annual Budget of Sangguniang Kabataan of Barangay Motosawa, Dumalinao, Zamboanga del Sur, for FY 2023, amounting to Three Hundred Two Thousand Five Hundred Thirty-Two Pesos and Seventy Centavos (Php302, 532.70), subject to all accounting and auditing rules and procedure.

**LET** the copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.
