**RESOLUTION NO. 002-2022**

**AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLO R. S. CERILLES TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE RURAL BANK OF RIZAL (ZN), INCORPORATED – PAGADIAN BRANCH, REPRESENTED BY ITS PRESIDENT, ATTY. ALBERT T. CONCHA, JR., AND MANAGER GREG IAN B. CHENG FOR THE SALARY LOAN FACILITY FOR LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR.**

**WHEREAS**, presented to this august body for appropriate action, is the authorization of the Local Chief Executive to enter into a Memorandum of Agreement by and between the Rural Bank of Rizal (ZN), Incorporated – Pagadian Branch, represented by its President, Atty. Albert T. Concha, Jr., and Manager Greg Ian B. Cheng for the Salary Loan Facility for Local Government Unit of Dumalinao, Zamboanga del Sur;

**WHEREAS**, Section 22 (c) of R.A 7160, otherwise known as the Local Government Code of 1991, provides, that every local government unit, as a corporation, shall, unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall



be posted at a conspicuous place in the provincial capitol or the city, municipal or barangay hall;

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, the Rural Bank of Rizal (ZN), Incorporated – Pagadian Branch is offering a Salary Loan Facility to the Local Government Unit of Dumalinao, who are municipal elected employee/officials;

**WHEREAS**, the loanable amount is based on the latest net take-home pay, and the loan availment shall not be for a period of more than thirty-six (36) months and shall be paid in equal monthly amortizations through periodic salary deductions to begin one month after the date the loan is granted;

**WHEREAS**, after careful review and exhausted deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. JELITO R. PEÑONAL** the body resolved, as it hereby resolves to authorize the Honorable Mayor Junafior S. Cerilles, RMT, MAGD, to enter into a Memorandum of Agreement (MOA) by and between the Rural Bank of Rizal (ZN), Incorporated – Pagadian Branch, represented by its President, Atty. Albert T. Concha, Jr., and Manager Greg Ian B. Cheng for the Salary Loan Facility for Local Government Unit of Dumalinao, Zamboanga del Sur.




