RESOLUTION NO. 008-2022

ADOPTING THE APPROVED LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN RESOLUTION NO. 01 SERIES OF 2022 ENTITLED "A RESOLUTION APPROVING THE REALIGNED LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN BUDGET AND A RESOLUTION REQUESTING THE SANGGUNIANG BAYAN FOR ITS ADOPTION" SUBJECT TO ALL LEGAL LAWS, ACCOUNTING AND AUDITING RULES AND REGULATIONS.

WHEREAS, presented to this august body for appropriate action is the approved realignment of budget of the Local Council for the Protection of Children of the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, Section 16 of the Local Government Code of 1991, provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;



WHEREAS, Section 17 (b) (2) (iv) of the same Code provides that the LGUs shall provide basic services which include programs and projects on child and youth welfare, family and community welfare, women's welfare, welfare of the elderly and disabled persons; community-based rehabilitation programs for vagrants, beggars, street children, scavengers, juvenile delinquents and victims of drug abuse; livelihood and other pro-poor projects; nutrition services; and family planning services;

WHEREAS, the Local Council for the protection of Children is mandated to assist the Local Government Units in the promotion of the rights of children, protection of their welfare, and ensure efficient and appropriate interventions to address the issues concerning children in the locality;

WHEREAS, on July 12, 2022, the Local Council for the protection of Children passed LCPC Resolution No. 01 Series of 2022 approving the realignment of LCPC Budget amounting to Three Hundred Ninety Thousand Pesos (Php390, 000.00), sourced from existing PPAs of the current appropriations of the said budget, to wit:
