**RESOLUTION NO. 010-2022**

**RESPECTFULLY REQUESTING THE PROVINCIAL GOVERNOR OF ZAMBOANGA DEL SUR HONORABLE GOVERNOR VICTOR J. YU TO DESIGNATE ENGR. RANDOLF B. ILAGAN A REGISTERED ELECTRICAL ENGINEER UNDER THE OFFICE OF THE PROVINCIAL ENGINEER TO BE THE ELECTRICAL INSPECTOR AND TO SIGN FOR ELECTRICAL PERMITS RECOMMENDATION, CERTIFICATIONS AND OTHER DOCUMENTS IN THE MUNICIPAL ENGINEERING OFFICE/OFFICE OF THE BUILDING OFFICIAL IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.**

**WHEREAS**, presented to this august body for appropriate action is the request of the Municipal Engineer, requesting the provincial governor of Zamboanga del Sur, Honorable Governor Victor J. Yu, to designate Engr. Randolph B. Ilagan, under the Office of the Provincial Engineer, to be the electrical inspector and to sign for electrical permits recommendation, certifications and other documents in the Office of the Municipal Engineer/Office of the Building Official in the Municipality of Dumalinao, Zamboanga del Sur.

**WHEREAS**, the Municipality of Dumalinao has no electrical engineer who is employed to inspect and sign for electrical permits recommendation,



certifications, and other documents which is required by the National Building Code of the Philippines;

**WHEREAS**, Engr. Rondolf B. Ilagan has been assigned in the municipality for past years and to other municipalities performing said functions;

**WHEREAS**, the LGU-Dumalinao has not yet created such position and/or item for the meantime considering the budget availability of the locality;

**WHEREAS**, viewed from the forgoing this august body finds the necessity to request the good Governor, Honorable Victor J. Yu, for the subject purpose designation;

**WHEREAS**, after careful review and exhausted deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. FREDERICK R. BALANDRA** the body resolved, as it hereby resolves to request the provincial governor of Zamboanga del Sur, Honorable Governor Victor J. Yu, to designate Engr. Randolph B. Ilagan, under the Office of the Provincial Engineer, to be the electrical inspector and to sign for electrical permits recommendation, certification and other documents in the Office of the Municipal Engineer/Office of the Building Official in the Municipality of Dumalinao, Zamboanga del Sur.
