RESOLUTION NO. 0100-2022

AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, AND THE MUNICIPAL TREASURER, MR. GUALBERTO U. GEMINA, JR., TO OPEN A SEPARATE BANK ACCOUNT UNDER THE ACCOUNT NAME OF MUNICIPALITY OF DUMALINAO FEED MILL ECONOMIC ENTERPRISE OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR FOR THE OPERATION THEREOF.

WHEREAS, presented for consideration and appropriate action is the request of Local Chief Executive to open a separate bank account under the account name of Municipality of Dumalinao Feed Mill Economic Enterprise of the Local Government Unit of Dumalinao for the operation thereof;

WHEREAS, Section 444 (b), (1), (vi), Article I, Chapter III of R.A 7160 otherwise known as the Local Government Code of 1991, provides that for efficient, effective and economical governance the purpose of which is the general welfare of the municipality and its inhabitant, the municipal mayor, upon the authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contract, and obligations and such other documents made pursuant to law or ordinance;



WHEREAS, Section 470 (d), (2), Article II of the same Code, states that the treasurer shall take charge of the treasury office, perform the duties provided for under Book II of this Code, and shall take custody and exercise proper management of the funds of the local government unit concerned;

WHEREAS, for the implementation and operation of the Feed Mill Economic Enterprise and, at the same time to ensure the agro-industrial development in an end view to save the farmers, hence, this request;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. HERMES B. CABALES, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, and the Municipal Treasurer, Mr. Gualberto U. Gemina, Jr., to open a separate bank account under the account name of Municipality of Dumalinao Feed Mill Economic Enterprise of the Local Government Unit of Dumalinao, Zamboanga del Sur for the operation thereof.

LET the copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.
