RESPECTFULLY REQUESTING OFFICE IN-CHARGE REGIONAL DIRECTOR, JOSHUA G. BRILLANTES, MD, MPH, CESO IV OF THE DEPARTMENT OF HEALTH ZAMBOANGA PENINSULA-CENTER FOR HEALTH DEVELOPMENT THROUGH HUMAN RESOURCES FOR HEALTH (HRH) TO AUGMENT HEALTH CARE PROFESSIONALS IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the request of the Municipal Health Officer, requesting OIC-Regional Director Joshua G. Brillantes, MD, MPH, CESO IV of the Department of Health Zamboanga Peninsula-Center for Health Development through Human Resources for Health (HRH) to augment health care professionals in the locality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;



WHEREAS, under the National Health Workforce Support System (NHWSS) provides that the priority areas for deployment in 2023 shall include fifth (5th) and sixth (6th) class municipalities, Geographically Isolated and Disadvantaged Areas (GIDA) municipalities, and those under the End Local Communist Armed Conflict (ELCAC);

WHEREAS, the Municipality of Dumalinao is a 4th class municipality in the Province of Zamboanga del Sur, which is politically subdivided into 30 barangays with an estimated population of 32 013;

WHEREAS, according to the Municipal Health Officer, there are eight (8) Geographically Isolated and Disadvantaged Areas (GIDA) remaining, and at the same time, there is a depletion of National Tax Allotment (NTA) of the locality;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. JELITO R. PEÑONAL**, the body resolved, as it hereby resolves to respectfully request the OIC-Regional Director Joshua G. Brillantes, MD, MPH, CESO IV of the Department of Health Zamboanga Peninsula-Center for Health Development through Human Resources for Health (HRH) to augment health care professionals in the Municipality of Dumalinao, Zamboanga del Sur.

SUBJECT: NATIONAL HEALTH WORKFORCE SUPPORT SYSTEM 2023
UPDATE

Per pertinent issuances on the devolution of Human Resource for Health (HRH) under the National Health Workforce Support System (NHWSS), priority areas for deployment in 2023 shall include fifth (5th) and sixth (6th) class municipalities, Geographically Isolated and Disadvantaged Areas (GIDA) municipalities and those under End Local Communist Armed Conflict (ELCAC). In view of this, all Provincial Department of Health Offices (PDOHOs) and City Department of Health Offices (CDOHOs) are hereby advised and instructed this early to reformulate a mechanism for evaluating all HRHs under their respective provinces and cities for renewal/reappointment to the areas/municipalities indicated above for next year's deployment.

As much as possible, all currently deployed HRHs who are interested to remain with the Deployment Program shall be subjected to such evaluation and ranking which shall not be limited only to the Individual Performance Commitment and Review (IPCR) rating. As such, currently deployed HRHs who are interested need not submit an application letter but only a Letter of Intent to be included in the evaluation and ranking. In addition, new applications shall likewise be entertained and evaluated.

Under the recent Department Order no. 2022-0451 on "Operational Guidelines in the Implementation of Select Human Resource for Health Composite Programs and Projects under the National Health Workforce Support System", the Provincial/City Department of Health Office shall conduct, facilitate and strategize the selection of HRH for 2023, the roles of which include but not limited to:

- Identify the deployment of HRH in priority areas that will serve as one of the means toward equitable distribution of health care professionals
- Present LGU plan to implement incremental creation of plantilla to require number of HRH to be deployed to include GIDA barangays, ELCAC and with indigenous cultural communities.
- Consolidate and evaluate HRH request for augmentation from Provincial/City Health Board/LGU based on gaps on staffing standard for health facilities.
- Validate priority areas of deployment based on the order of priority. Deployment of different cadres to localities shall highly consider the characteristics and status of municipalities and provinces.

For municipalities/cities not falling under the criteria above, but are with GIDA,ELCAC or Indigenous People (IP) barangays, Local Government Units (LGUs) shall make a request through Sanguniang Bayan/Sanguniang Panglungsod Resolution specifying the cadre, number and commitment to provide incentives and support, and all other specified in the said order.
