ADOPTING THE APPROVED MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 01 S' 2022 ENTITLED "A RESOLUTION REPROGRAMMING THE AMOUNT OF THREE MILLION (PHP3, 000, 000.00) PESOS TAKEN FROM MDC RESOLUTION NUMBER 4 SERIES OF 2020 AMOUNTING TO TWO MILLION (PHP2, 000, 000.00) PESOS AND MDC RESOLUTION NUMBER 2 SERIES OF 2021 AMOUNTING TO ONE MILLION (PHP1, 000, 000.00) PESOS 20% ECONOMIC DEVELOPMENT FUND (EDF) PROGRAMMING FOR THIS MUNICIPALITY" SUBJECT TO ALL LEGAL LAWS, ACCOUNTING AND AUDITING RULES AND REGULATIONS.

WHEREAS, presented to this august body for appropriate action is the approved reprogram of budget of the Municipal Development Council (MDC) of the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, Section 16 of the Local Government Code of 1991, provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the Local Government Unit of Dumalinao through the Municipal Development Council needs to reprogram the continuing and current appropriations from the 20% Economic Development Fund (EDF) in order to provide various developmental projects which are found to be of great necessity of promoting good governance to the locality;

WHEREAS, June 21, 2022, the Municipal Development Council (MDC) passed MDC Resolution No. 01 S' 2022, reprogramming the 20% EDF current and continuing appropriations amounting to Three Million Pesos (Php3, 000, 000.00), to wit:
