### **RESOLUTION NO. 0110-2022**

RESPECTFULLY REQUESTING HONORABLE GOVERNOR VICTOR J. YU OF THE PROVINCE OF THE ZAMBOANGA DEL SUR TO PROVIDE ONE (1) UNIT OF BONGGO VEHICLE TO EACH BARANGAYS, TO WIT: 1. BIBILIK; 2. BAG-ONG MISAMIS; 3. MAMA; 4. METOKONG; 5. PINIGLIBANO; 6. LOCUBAN; AND 7. MALASIK, ALL IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabales to request Honorable Governor Victor J. Yu of the Province of Zamboanga del Sur to provide one (1) unit of Bonggo vehicle to each barangays, to wit; 1. Bibilik; 2. Bag-ong Misamis; 3. Mama; 4. Metokong; 5. Piniglibano; 6. Locuban; and 7. Malasik, all in the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective





governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, in the light of extending assistance to ease the need for convenient transport and to even hasten the supply of farm inputs and farm produce vehicle is quite imperative in far-flung and remote barangays;

WHEREAS, it has been a long desire and need of the aforementioned barangay and the inhabitants hereof to have a transport facility responsive to the immediate and emergency needs of the people;

WHEREAS, the mentioned barangays have good access to transportation facilities, deficient, however, to finance to avail of so that this purport is sought;

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. HERMES B. CABALES, the body resolved, as it hereby resolves to request Honorable Governor Victor J. Yu of the Province of Zamboanga del Sur to provide one (1) unit of Bonggo vehicle to each barangays, to wit; 1. Bibilik; 2. Bag-ong Misamis; 3. Mama; 4. Metokong; 5. Piniglibano; 6. Locuban; and 7. Malasik, all in the Municipality of Dumalinao, Zamboanga del Sur.
