RESOLUTION NO. 0111-2022

AUTHORIZING THE GRANT OF SERVICE RECOGNITION INCENTIVE (SRI) TO QUALIFIED MUNICIPAL OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR FOR CALENDAR YEAR 2022 IN THE TOTAL AMOUNT OF TWO MILLION SIX HUNDRED EIGHT THOUSAND PESOS (PHP2, 608, 000.00).

WHEREAS, presented for consideration and appropriate action is the grant of Service Recognition Incentive (SRI) to qualified municipal officials and employees of the Local Government Unit of Dumalinao, Zamboanga del Sur for CY 2022 in the total amount of Two Million Six Hundred Eight Thousand Pesos (PHP2, 608, 000.00);

WHEREAS, President Ferdinand R. Marcos, Jr., issued Administrative Order No. 01, dated December 16, 2022, authorizing the grant of Service Recognition Incentive (SRI) to Government Employees for Fiscal Year 2022 to acknowledge all government employees for their collective and invaluable contribution to the government's continuing efforts to ensure responsive delivery of services to the public, especially in the midst of the continuing public health emergency due to the COVID-19 pandemic and other socio-economic challenges;

WHEREAS, Section 6 of Administrative Order No. 01, SRI for Employees in Local Government Units (LGUs) states that the grant of the one-time SRI to employees in LGUs, including those in the barangays, shall be determined by their respective sanggunians depending on the LGUs financial capability, subject to the PS limitation in LGU budgets under RA No. 7160 or the "Local Government Code of 1991," and the conditions set forth in Section 2 hereof, at a uniform rate not exceeding Twenty Thousand Pesos (Php20, 000.00), chargeable against their respective FY 2022 local government funds;

WHEREAS, under Appropriation Ordinance No. 2021-12-461, the LGU-Dumalinao allocated Service Recognition Incentives (SRI) under the different offices amounting to Ten Thousand Pesos (Php10, 000.00) per municipal official and employee in the total amount of One Million Four Hundred Thirty Thousand Pesos (Php1, 430, 000.00);

WHEREAS, under Section 7 of Appropriation Ordinance No. 2021-12-461, states that the Municipal Mayor and the Municipal Vice Mayor are hereby authorized to augment any item of appropriation in this budget for their respective executive and legislative officers by the way of Executive Order and Resolution respectively, from appropriation savings, within the same expense class of the office;

WHEREAS, the available Personal Services Savings of the Mayor's Office and Sangguniang Bayan Office, covering the terminal leave benefits that shall be used to augment funds to Personal Services of the municipality to appropriate the grant of Service Recognition Incentives (SRI) with the total amount of One Million Two Hundred Nineteen Two Hundred Twenty-Seven Pesos and Ninety Centavos (Php1, 219,227.90), as follows:

WHEREAS, the Municipal Budget Officer had certified that as per book of accounts of the said offices, the various items was found out available as of date and can be a source of augmentation;

WHEREAS, to date, the municipality has a total of one hundred thirty-one (131) qualified officials and employees entitled to receive the Service Recognition Incentives (SRI) under Administrative Order No. 01;

WHEREAS, the LGU-Dumalinao has sufficient budget to authorize the grant of Service Recognition Incentives (SRI) at a uniform amount not exceeding Twenty Thousand Pesos (Php20, 000.00) for all qualified municipal officials and employees



in the total amount of Two Million Six Hundred Eight Thousand Pesos (PHP2, 608, 000.00), to wit:
