## **RESOLUTION NO. 0113-2022**

APPROVING THE AUGMENTATION OF FUNDS FROM THE SAME EXPENSE CLASS OF PERSONAL SERVICES (PS) SAVINGS IN THE SUM OF FORTY ONE THOUSAND TWO **HUNDRED TWENTY SEVEN PESOS AND NINETY CENTAVOS (PHP41, 227.90) UNDER THE** TERMINAL LEAVE BENEFITS OF THE OFFICE OF THE SANGGUNIANG BAYAN OF DUMALINAO, ZAMBOANGA DEL SUR TO COVER THE CASH GIFT AND YEAR-END BENEFITS THEREOF.

WHEREAS, presented for consideration and appropriate action is augmentation of funds from PS to PS under the terminal leave benefits of the Office of the Sangguniang Bayan, Dumalinao, Zamboanga del Sur to cover the cash gift and year-end benefits thereof;

WHEREAS, under Section 7 of Appropriation Ordinance No. 2021-12-461 provides that the Municipal Mayor and the Municipal Vice Mayor are hereby authorized to augment any item of appropriation in this budget for their respective executive and legislative officers by the way of Executive Order and Resolution respectively, from appropriation savings, within the same expense class of the office;
