#### **RESOLUTION NO. 0114-2022**

ADOPTING THE APPROVED 20% ECONOMIC DEVELOPMENT FUND (EDF) OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR AMOUNTING TO TWENTY-NINE MILLION ONE HUNDRED ELEVEN THOUSAND SEVEN HUNDRED FIFTY-TWO PESOS (PHP 29,111,752.00) FOR CALENDAR YEAR 2023.

WHEREAS, presented for consideration and appropriate action is 20% Economic Development Fund (EDF) of the Municipality of Dumalinao, Zamboanga del Sur amounting to Twenty-Nine Million One Hundred Eleven Thousand Seven Hundred Fifty-Two Pesos (Php29,111,752.00) for CY 2023;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare:
