#### **RESOLUTION NO. 0117-2022**

APPROVING AND ADOPTING THE FOLLOWING PLANS OF THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL, TO WIT: 1. DISASTER REHABILITATION PLAN; 2. CONTINGENCY PLAN FOR TSUNAMI; AND 3. URBAN FIRE CONTINGENCY PLAN IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the following plans of the MDRRM Council, to wit: 1. Disaster Rehabilitation Plan; 2. Contingency Plan for Tsunami; and 3. Urban Fire Contingency Plan in the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare:





WHEREAS, under Section 12 of Republic Act No. 10121, the Local Disaster Risk Reduction and Management Council (LDRRMC) is mandated to take the lead in preparing for responding to and recovering from the adverse effects of any disaster to strengthen its capacity towards mitigation, preparedness, response and recovery to reduce risks to human life and assets, and build disaster resilient communities;

WHEREAS, the formulation and implementation of the above plans are anchored on scientific knowledge and a deep understanding of the municipality hazards, vulnerability, and risk to human-induced or natural disaster or calamities, and has undertaken a collaborative and comprehensive planning process for addressing, preparing, mitigating and preventing the effects of various forms of disaster and emergencies;

WHEREAS, through these plans, the Local Government Unit of Dumalinao develops a comprehensive emergency management program that will provide a system to mitigate the effects of an emergency or disaster, preserve life, respond during emergencies, provide necessary assistance, and establish a recovery system in the locality;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. HERMES B. CABALES, the body resolved, as it hereby resolves to approve and adopt the following plans of the Municipal Disaster Risk Reduction and Management Council, to wit: 1. Disaster Rehabilitation Plan; 2. Contingency Plan for Tsunami; and 3. Urban Fire Contingency Plan in the Municipality of Dumalinao, Zamboanga del Sur.
