RESOLUTION NO. 0118-2022

AUTHORIZING THE LOCAL CHIEF EXECUTIVE HONORABLE MAYOR JUNAFLO R. S. CERILLES, RMT, MAGD, TO APPLY AND ENTER INTO A LOAN AGREEMENT BY AND BETWEEN LAND BANK OF THE PHILIPPINES (LBP) FOR THE FUNDS OF THE PROPOSED CONSTRUCTION AND LOT ACQUISITION OF DUMALINAO PUBLIC MARKET AND INTEGRATED BUS TERMINAL OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra to authorize the Local Chief Executive to apply and enter into a loan agreement by and between the Land Bank of the Philippines (LBP) for the funds of the proposed construction and lot acquisition of Dumalinao Public Market and Integrated Bus Terminal of the locality;

WHEREAS, Section 22 (c) of R.A 7160, otherwise known as the Local Government Code of 1991, provides, that every local government unit, as a corporation, shall, unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;



WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, it is the policy of the LGU-Dumalinao to be self-reliant and self-sufficient through engaging in a viable and stable economic enterprise that provides a wide range of opportunities that will uplift the socio-economic well-being of its constituents, improve fiscal management and enhance good governance;

WHEREAS, the Land Bank of the Philippines (LBP) is a government-owned financial institution that aims to strike a balance in fulfilling its social mandate of promoting countryside development in the country;

WHEREAS, the august body finds it necessary with the end view of upgrading the delivery and operation of Dumalinao Public Market and Integrated Bus Terminal in an expeditious, cost-effective, and economical enterprise manner;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. FREDERICK R. BALANDRA**, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junafior S. Cerilles, RMT, MAGD, to apply and enter into a loan agreement by and between the Land Bank of the Philippines (LBP) for the funds of the proposed construction and lot acquisition of Dumalinao Public Market and Integrated Bus Terminal of the Municipality of Dumalinao, Zamboanga del Sur.
