**WHEREAS**, the LGU-Dumalinao supports in providing basic education and ensures to create of a safe learning environment in the locality;


**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

1. The Department of Education Central Office is on the process of crafting the guidelines on redistricting pursuant to DepEd Memorandum No. 026, s. 2021. This aims to define indicators and standards in creating school districts in preparation for Schools Division Offices classifications.
2. In view thereof, all Government Authorities issued for redistricting are hereby revoked/canceled effective immediately. Thus, all created school districts shall be returned to the mother districts and designations of the District In-charge deemed recall.
3. In addition, all redistricting requests endorsed to DepEd Regional Office, shall be put on hold until an updated policy and guidelines related to school redistricting have been issued.
