RESOLUTION NO. 0124-2023

RESPECTFULLY REQUESTING THE DEPARTMENT OF AGRICULTURE REGION-IX AND THE DEPARTMENT OF AGRARIAN REFORM REGION-IX TO PROVIDE A LIST OF REQUIRED DOCUMENTS NECESSARY FOR THE RECLASSIFICATION OF LAND FROM AGRICULTURAL TO RESIDENTIAL LAND, WHICH WILL SERVE AS A GUIDE OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR IN HANDLING APPLICANTS SEEKING FOR RECLASSIFICATION IN THE MUNICIPALITY.

WHEREAS, presented for consideration and appropriate action the proposed resolution of Hon. Rholly A. Labang to request the Department of Agriculture Region-IX and the Department of Agrarian Reform Region-IX to provide a list of required documents necessary for the reclassification of land from agricultural to residential land, which will serve as a guide of the Local Government Unit of Dumalinao, Zamboanga del Sur in handling applicants seeking for reclassification in the municipality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective





governance, and those which are essential to the promotion of the general welfare;

WHEREAS, the Committee on Zoning and Land Use has a referred application of reclassification of land from agricultural to residential within the locality;

WHEREAS, the Department of Agriculture (DA) and Department of Agrarian Reform (DAR) are the reviewing agency and issues clearance for the reclassification of agricultural to residential land within the municipality;

WHEREAS, the august body finds it necessary to ask the above-mentioned departments to provide a list of required documents for the reclassification process as part of their mandate, which will serve as a guide in handling applicants seeking for reclassification process within the locality;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. RHOLLY A. LABANG, the body resolved, as it hereby resolves to request the Department of Agriculture Region-IX and the Department of Agrarian Reform Region-IX to provide a list of required documents for the reclassification of land from agricultural to residential land, which will serve as a guide of the Local Government Unit of Dumalinao, Zamboanga del Sur in handling applicants seeking for reclassification process in the municipality.
