EARNESTLY REQUESTING THE CONGRESSWOMAN OF 2ND DISTRICT OF ZAMBOANGA DEL SUR, HONORABLE JEYZEL VICTORIA C. YU TO ALLOCATE FUNDS FOR THE ESTABLISHMENT OF TEEN CENTER IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Honorable Ma. Gemma C. Albiso to request the Congresswoman of 2nd District, Honorable Jeyzel Victoria C. Yu to allocate funds for the establishment of Teen Center in the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, the LGU-Dumalinao has adopted the policy of the state under the 1987 Philippine Constitution in recognizing the vital role of the youth in nation-building and to promote their physical, moral, spiritual, intellectual, and social well-being;
