RESOLUTION NO. 0132-2023

LIFTING THE RESOLUTION NO. 0261-2022, DATED FEBRUARY 7, 2022, ENTITLED "GRANTING INCENTIVE TO ALL MOTORIZED VEHICLE FOR HIRE WHO ARE FULLY VACCINATED AND A MEMBER OF A REGISTERED/ACCREDITED TRANSPORT ASSOCIATION APPLYING OF OPERATORS PERMIT/FRANCHISE IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR".

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabaless to lift the grant of incentive of Resolution No. 0261-2022 of the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;



WHEREAS, the 11th Legislative Council passed a resolution granting incentives to all motorized vehicles for hire which are fully vaccinated and a member of a registered/accredited transport association in applying for operators permit/franchise in the locality;

WHEREAS, the said grant provides a respective discount to partially vaccinated, fully vaccinated, and fully vaccinated plus booster shots in order to protect and promote the right to health during the pandemic in consonance with Inter-Agency Task Force Resolution No. 148-B Series of 2021;

WHEREAS, the resulting effect of the pandemic has crippled the economy of the country, which was felt most by the law-class municipality, thus affecting employment in all sectors as well as the income generated by the local government unit;

WHEREAS, there has been a positive and high percentage of vaccination turnout in the municipality of Dumalinao, thus employment and daily economic activities has now returned back to the new normal;

WHEREAS, as the new normal sets in and following with the vaccination of the labor force in the locality, including the accredited transport association, the LGU deems it's best and appropriate to lift the previous grant of incentive couched under Resolution No. 0261-2022;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. HERMES B. CABALES**, the body resolved, as it hereby resolves to lift the Resolution No. 0261-2022, dated February 7, 2022, entitled "*granting incentive to all motorized vehicle for hire who are fully vaccinated and a member of a registered/accredited transport association applying of operators permit/franchise in the Municipality of Dumalinao, Zamboanga del Sur*".
