CERILLES, RMT, MAGD, TO ENTER INTO A MEMORANDUM OF AGREEMENT BY AND BETWEEN THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT COMMITTEES THE BARANGAYS OF ANONANG, BAGA, BAG-ONG MISAMIS, BAG-ONG SILAO, BALOBOAN, BANTA-AO, BIBILIK, CALINGAYAN, CAMALIG, CAMANGA, CUATRO-CUATRO, LOCUBAN, MALASIK, MAMA, MATAB-ANG, MECOLONG, METOKONG, MOTOSAWA, PAG-ASA, PAGLAUM, PANTAD, PINIG-LIBANO, REBOKON, SAN AGUSTIN, SEBUCAO, SUMADAT, TICKWAS, TINA, TUBO-PAIT AND UPPER DUMALINAO, REPRESENTED BY BARANGAY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL CHAIRPERSON OF RESPECTIVE BARANGAYS FOR THE IMPLEMENTATION OF THE DUMALINAO DISASTER RISK REDUCTION AND MANAGEMENT ALLIANCE.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Jessie Niel C. Paulo to authorize the Local Chief Executive to enter into a Memorandum of Agreement by and between the Local Disaster Risk Reduction and Management Committees of all Barangay Local Government

Units in the Municipality of Dumalinao, Zamboanga del Sur for the implementation of the of Dumalinao Disaster Risk Reduction and Management Alliance;

WHEREAS, Section 22 (c) of R.A 7160, otherwise known as the Local Government Code of 1991, provides, that every local government unit, as a corporation, shall, unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;

WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Dumalinao Disaster Risk Reduction and Management Alliance is composed of thirty (30) Barangay Local Government Units, who expressed their mutual commitment in order to promote cooperation and to have a costefficient initiation and implementation of all municipal-wide activities related to Disaster Risk Reduction and Management Programs in the locality;

WHEREAS, the Local Government Unit of Dumalinao strongly support the Dumalinao Disaster Risk Reduction and Management Alliance to ensure the safety and resiliency of communities to face the challenges of disasters;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. JESSIE NIEL C. PAULO, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to enter into a Memorandum of Agreement (MOA) by and between the Local Disaster Risk Reduction and Management Committees the Barangays of Anonang, Baga, Bag-ong Misamis, Bag-ong Silao, Baloboan, Banta-ao, Bibilik, Calingayan, Camalig, Camanga, Cuatro-cuatro, Locuban, Malasik, Mama, Matab-ang, Mecolong, Metokong, Motosawa, Pag-asa, Paglaum, Pantad, Pinig-libano, Rebokon, San Agustin, Sebucao, Sumadat, Tickwas, Tina, Tubo-pait and Upper Dumalinao, represented by Barangay Disaster Risk Reduction and Management Council chairperson of respective barangays for the implementation of the Dumalinao Disaster Risk Reduction and Management Alliance.

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THIS PRESENTS:

This Agreement is entered into by and among:

The LOCAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL OF THE MUNICIPALITY OF DUMALINAO, a local special body, organized under Executive Order No. ____, series of 2023 and under pertinent existing laws with office address at Municipal Hall, Poblacion Dumalinao, Zamboanga Del Sur, represented by its Chairperson HON. JUNAFLOR S. CERILLES, Municipal Mayor, hereinafter referred to as "FIRST PARTY";

The LOCAL DISASTER RISK REDUCTION AND MANAGEMENT COMMITTEES OF THE BARANGAYS OF ANONANG, BAGA, BAG-ONG MISAMIS, BAG-ONG SILAO, BALOBOAN, BANTA-AO, BIBILIK, CALINGAYAN, CAMALIG, CAMANGA, CUATRO-CUATRO, LOCUBAN, MALASIK, MAMA, MATAB-ANG, MECOLONG, METOKONG, MOTOSAWA, PAG-ASA, PAGLAUM, PANTAD, PINIG-LIBANO, REBOKON, SAN AGUSTIN, SEBUCAO, SUMADAT, TICKWAS, TINA, TUBO-PAIT AND UPPER DUMALINAO, all of Dumalinao, Zamboanga del Sur, all local special bodies, organized under Executive Orders, all series of 2023, respectively, and under pertinent existing laws with respective office addresses at their Barangay Hall, all of Dumalinao, Zamboanga Del Sur, represented in this agreement by their respective Chairpersons, hereinafter collectively referred to as "SECOND PARTY"

WITNESSETH

WHEREAS, the "FIRST PARTY" had been strongly implementing the Republic Act 10121 otherwise known as "An Act Strengthening The Philippine Disaster Risk Reduction and Management System, providing for the National Disaster Risk Reduction and Management Framework and Instituting The National Disaster Risk Reduction and Management Plan;

WHEREAS, the need to be prepared before, during and after disasters are of great value to constituents and local officials of Dumalinao, Zamboanga del Sur;

WHEREAS, prevalent financial deficiencies of the LDRRMCs of both Municipal and Barangay levels had been established as the primary factor in not fully attaining the goals of RA 10121, apart from the troubling issue on non-functionality of BDRRMCs;

WHEREAS, due financial constraints of local DISASTER RISK REDUCTION AND MANAGEMENT COMMITTEES (BDRRMCs) of the thirty (30) Barangays of the municipality as well as the Municipal DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL, there is a need to form an alliance in order to cost-efficiently promote cooperation and mutual support for the attainment of common interests and purposes in the municipal-wide implementation of all DRRM PPAs;

WHEREAS, during the conduct of iCBDRRM plan Monitoring and Evaluation activities, all local DISASTER RISK REDUCTION AND MANAGEMENT COMMITTEES (BDRRMCs) had unanimously admitted their collective and imperative needs for sustained guidance and technical assistance in the implementation of the Plans, Programs, and Activities under the four Thematic Pillars of the Philippine DRRM system;

WHEREAS, the thirty (30) BDRRMC Chairpersons composing the Dumalinao Liga ng mga Barangay, which are all hereto referred to as the "SECOND PARTY", had issued Resolution No. 01-01-2023, series of 2023, favorably indorsing the organization of the Dumalinao Disaster Risk Reduction & Management Alliance (DDRRM "A"), dated January 11, 2023;

WHEREAS, all parties of this agreement unite towards undertaking to organize the said alliance for all necessary DRRM intents and purposes;

WHEREAS, the MDRRMC Chairperson	as the Local C	Chief Executive is o	duly empowered by

WHEREAS, the thirty (30) BDRRMC Chairpersons as Local Chief Executives of their respective Barangays are duly empowered by Law to enter into, sign and execute this Memorandum of Agreement on behalf of their respective Barangays through local Resolutions, as indicated below:

NOW THEREFORE, for and in consideration of the foregoing premises and their common covenants hereinafter set forth, the parties hereby agree on the following terms and conditions;

ARTICLE I NAME OF THE ALLIANCE

Section 1. The Coalition shall be named as Dumalinao Disaster Risk Reduction & Management Alliance or DDRRM "A".

ARTICLE II PURPOSE OF THE AGREEMENT

Section 1. This agreement by and among the LOCAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL OF THE MUNICIPALITY OF DUMALINAO and LOCAL DISASTER RISK REDUCTION AND MANAGEMENT COMMITTEES OF THE BARANGAYS OF ANONANG, BAGA, BAG-ONG MISAMIS, BAG-ONG SILAO, BALOBOAN, BANTA-AO, BIBILIK, CALINGAYAN, CAMALIG, CAMANGA, CUATRO-CUATRO, LOCUBAN, MALASIK, MAMA, MATAB-ANG, MECOLONG, METOKONG, MOTOSAWA, PAG-ASA, PAGLAUM, PANTAD, PINIG-LIBANO, REBOKON, SAN AGUSTIN, SEBUCAO, SUMADAT, TICKWAS, TINA, TUBO-PAIT AND UPPER DUMALINAO express mutual commitment of the parties in order to organize and alliance for the effective and coast-efficient initiation and implementation of all municipal-wide activities related to Disaster Risk Reduction and Management Programs.

ARTICLE III SCOPE OF THE AGREEMENT

- Section 1. The herein organized Dumalinao Disaster Risk Reduction & Management Alliance composing of its members hereby respectively commit and bind themselves to perform the herein set forth scope of their agreement.
- Section 1.1. Each member BDRRMC of the Dumalinao Disaster Risk Reduction & Management Alliance shall allocate annually the total amount of TEN THOUSAND PESOS (Php10,000.00), provided that the MDRRMC shall likewise allocate any amount not less than THREE HUNDRED THOUSAND PESOS (Php300,000.00), as their respective fund counterparts chargeable against the 70% of their LDRRM funds.
- Section 1.2. The agreed counterpart amount of each member BDRRMC shall be remitted before the end of first quarter each year, including the founding year, and shall be made payable to the Local Government of Dumalinao, Zamboanga dle Sur.
- Section 1.3. The Alliance Fund shall be utilized exclusively for the following DRRM programs, projects, and activities, but not limited to:
 - a. Emergency Transportation or Transport of Cadaver
 - b. Procurement of DRRM tools and equipment
 - c. Procurement of goods for prepositioning
 - d. Training
 - e. Drills
 - f. Early Warning Systems and devices
 - g. IEC materials
 - h. Risk, Exposure, and Vulnerability Assessment
 - i. fund augmentation during state of emergency or calamity
- Section 1.4. No other DRRM programs, projects, and activities not included in the preceding section shall be approved for fund allocation without approval of at least 3/4 of the members present during the deliberation. In no case that non-DRRM programs, projects, and activities be approved for fund allocation or implementation.
- Section 2. All teams and sub-committees of each BDRRMC organizations shall be treated as alliance members for purposes of DRRM trainings, whereby they shall be clustered according to their risks, exposures, and vulnerabilities. The trained and clustered Incident Management Team (IMT) shall be deployed and/or augmented to the affected areas supposedly managed by any fellow alliance member in the event of their gross incapability. The ordering of resource shall be coursed through the operating Emergency Operations Center (EOC) under Incident Command System (ICS) standard protocols.
- **Section 3.** No member of the alliance shall be qualified to access any fund or services of the same in the event of its failure to remit its counterpart as mandated under Section 1.2 hereof, provided that full benefit shall be restored upon full payment of its counterpart and arrears, if there is any.

ARTICLE IV ROLES AND RESPONSIBILITIES OF THE PARTIES

Section 1.1 The FIRST PARTY shall:

- a. Allocate fund counterpart to the alliance;
- b. Facilitate alliance regular and special meetings;
- c. Provide or assist in providing technical assistance in all DRRM activities of the alliance and its members;
- d. Manage, disburse, and liquidate fund utilization of the alliance;
- e. Open and maintain Trust Account specific for the alliance funds;
- f. Ensure functionality of the alliance, and;
- f. Perform other obligations and duties as may be deemed mutually beneficial to all parties.

Section 1.2 The SECOND PARTY shall:

- a. Allocate and remit fund counterpart to the alliance;
- b. Attend alliance regular and special meetings
- c. Request technical and other kind of assistance in all DRRM activities in their



- d. Require the MDRRMC periodic alliance fund utilization reporting
- e. Maintain and manage all tools and equipment of the alliance, and;
- f. Perform other obligations and duties as may be deemed mutually beneficial to all parties.

ARTICLE V AMENDMENTS

- Section 1. This Agreement may be modified by mutual consent of all parties. Any alteration or modification of this agreement must be done by an arrangement in writing among the Parties.
- Section 2. Any amendment or change to this Agreement will be subject to discussion and agreement among the Parties.
- Section 3. If any issue or dispute arises between the Parties concerning the matters covered by this Agreement, the Parties shall use their best endeavor to resolve the dispute promptly and amicably.

ARTICLE VI EFFECTIVITY

- Section 1. This Agreement shall take effect upon signing by the Parties hereto, and shall remain in full force and effect until the termination unless mutually terminated by the said Parties.
- Section 2. Either Party to this Agreement may initiate its termination in the event of default by the other Parties of any of their obligations herein set forth.
