RESOLUTION NO. 0141-2023

RESPECTFULLY REQUESTING THE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, HIS EXCELLENCY FERDINAND R. MARCOS, JR., THROUGH THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM), HONORABLE SECRETARY AMENAH F. PANGANDAMAN, TO ALLOCATE FUNDS TO VARIOUS PROPOSED PROJECTS IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra, to request President Ferdinand R. Marcos, Jr., through the Department of Budget and Management (DBM), Secretary Amenah F. Pangandaman, to allocate funds to various proposed projects in the Municipality of Dumalinao, Zamboanga del Sur, to wit:

1. Barangay Sumadat farm to market road – 2 kilometers distance;
2. Barangay Paglaum road concreting project – 1.5 kilometers distance;
3. Barangay Pinig-libano farm to market road – 2 kilometers distance;
4. Barangay Bibilik seawall construction – 600 meters;



5. Barangay Pantad seawall construction – 300 meters; and

6. Barangay Baga to Barangay Pantad road concreting – 4 kilometers distance;

WHEREAS, Section 17 (b) (2) (viii) of the Local Government Code of 1991, states that the LGU shall provide services and facilities include, but are not limited to infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including, but not limited to, municipal roads and bridges; school building and other facilities for elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring development, rainwater collectors and water supply system; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities, as part of the basic services devolved to the municipalities;

WHEREAS, the Municipality of Dumalinao is a 4th class municipality in the Province of Zamboanga del Sur, which is politically subdivided into 30 barangays with an estimated population of 32, 013;

WHEREAS, Dumalinao is an agricultural municipality wherein a large group of population is engaged in farming activities as their primary source of livelihood. In the same manner, they are the ones providing agricultural products to the municipality as well as the neighboring municipalities in the province in such a way that they are earning as well;

WHEREAS, the abovementioned projects will open easy access of farm products from and outside the place thus there will be smooth and faster delivery which will benefit the public especially the farmers;

WHEREAS, considering the limited resources of the Local Government, this august body deemed it necessary to source out funds, hence, to appeal to the President of the Republic of the Philippines, His Excellency Ferdinand R. Marcos, Jr., through the Department of Budget and Management (DBM), for financial assistance;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. FREDERICK R. BALANDRA**, the body resolved, as it hereby resolves, to respectfully request the President of the Republic of the Philippines, His Excellency Ferdinand R. Marcos, Jr., through the Department of Budget and Management (DBM), Honorable Secretary Amenah F. Pangandaman, to allocate funds to various proposed projects in the Municipality of Dumalinao, Zamboanga del Sur.
