RESOLUTION SUPPORTING THE LETTER REQUEST FROM THE MUNICIPAL MAYOR JUNAFLOR S. CERILLES, RMT, MAGD ADDRESS TO HON. WENDEL E. AVISADO SECRETARY OF DEPARTMENT OF BUDGET AND MANAGEMENT IN EARNESTLY REQUESTING FINANCIAL ASSISTANCE FOR THE ACQUISITION OF THE FOLLOWING:

1. TWO (2) UNITS AMBULANCE; AND 2. SOLAR STREET LIGHTS IN ORDER TO ILLUMINATE THE BOUNDARIES WITHIN MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR

WHEREAS, the Municipality of Dumalinao is a 4th class municipality in the Province of Zamboanga del Sur with an estimated population of 32, 013 people according to the 2015 census of Philippine Statistic Authority Region –IX;

WHEREAS, the municipality is a coastal town which is politically subdivided into 30 barangays;

WHEREAS, the locality is currently facing an ever increasing volume of patients who are coming not only from thirty (30) barangays comprising the entire municipality but also from nearby localities;

WHEREAS, the locality is located ten (10) kilometers from the provincial hospital in such a way that there are emergency cases in the locality that needs to referred to the hospital, whereby, a means of transportation is a necessity;

WHEREAS, the request of two (2) units of ambulance is necessary in order to facilitate better service to the constituents, in line with its mandate of serving the general public through health care;

WHEREAS, the locality is now moving to its progressive state with the presence of several investors and capitalist which the security factors shall be also considered. With the presence of street lights it will help to lessen any possible criminal activity. More importantly, it will facilitate the socio-economic activity of the inhabitants during early hours of the night;

WHEREAS, after finding the same to be of great importance and help, this august body finds it necessary to support the financial request in acquisition of the following: 1. Two (2) units of Ambulance; and 2. Solar Street Lights in order to illuminate the boundaries within the Municipality of Dumalinao, Zamboanga del Sur;

NOW, THEREFORE, premises above-considered, on motion by HON. ELYNOR S. CORTEZ the body resolved, as it hereby resolves to support the letter request from the Municipal Mayor Junaflor S.
