

RESOLUTION NO. 0144-2023

AUTHORIZING THE LOCAL CHIEF EXECUTIVE HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, OR HER AUTHORIZED REPRESENTATIVE TO NEGOTIATE ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, WITH THE HEIRS OF SEGUNDINA FOR THE ACQUISITION OF THE PARCEL OF LAND COVERED UNDER TAX DECLARATION NO. 16-05-0028-00093 LOCATED AT BARANGAY TINA, DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra to authorize the Local Chief Executive, or her authorized representative to negotiate on behalf of the Local Government Unit of Dumalinao with the Heirs of Segundina, owners of the above-described land for the acquisition thereof;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare:





WHEREAS, the municipal mayor is empowered by the law to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, the Tina Water System has been presently supplying potable water to more or less six barangays. The water supply therein is very vital in the day-to-day use of every household; thus, its source must be always established and maintained:

WHEREAS, the intake box and other water equipment materials owned by the LGU-Dumalinao as part of the water system have been permanently installed in the land owned by the Heirs of Segundina way back in 2016, up to present, located at Barangay Tina, Dumalinao, Zamboanga del Sur and covered by the Tax Declaration No. 16-05-0028-00093;

WHEREAS, the funds necessary in the negotiation for the acquisition of the subject property shall be taken from any available funds of the Local Government Unit of Dumalinao:

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. FREDERICK R. BALANDRA, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, or her authorized representative to negotiate on behalf of the Local Government Unit of Dumalinao with the Heirs of Segundina for the acquisition of the parcel of land covered under Tax Declaration No. 16-05-0028-00093 located at barangay Tina, Dumalinao, Zamboanga del Sur.

LET the copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.
