EARNESTLY REQUESTING THE HONORABLE CHRISTOPER LAWRENCE T. GO. SENATOR OF THE REPUBLIC OF THE PHILIPPINES, TO ALLOCATE FUNDS FOR THE PROPOSED CONSTRUCTION OF LEGISLATIVE BUILDING OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR, AMOUNTING TO TEN MILLION PESOS (PHP10, 000, 000.00).

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra to request the Senator Christoper T. Go, to allocate funds for the proposed construction of legislative building of the LGU-Dumalinao, Zamboanga del Sur, amounting to Ten Million Pesos (Php10, 000, 000.00);
