RESOLUTION NO. 0161-2023

ENABLING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLORES S. CERILLES, RMT, MAGD, TO ISSUE EXECUTIVE ORDER EFFECTING AUSTERITY AND INCOME GENERATING MEASURES IN THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabaless to enable the Local Chief Executive to issue Executive Order effecting austerity and income generating measures in the LGU-Dumalinao, Zamboanga del Sur;

WHEREAS, the Local Government Unit of Dumalinao is facing numerous challenges that require immediate action. With the current economic situation, the locality needs to find ways to generate additional revenue while reducing unnecessary expenses;

WHEREAS, it is wise and proper to take measures and mitigate, if not totally erase these circumstances;

WHEREAS, the august body hereby proposed that to implement austerity measures, all offices shall be required to off the lights and aircon from 12:00 noon to 1:00 o'clock in the afternoon to minimize the use of electricity, at the same moment, all offices must utilize the back page of used bond paper (scratch) for



communication and memorandum within the offices of the Local Government Unit of Dumalinao; likewise, cutting down on non-essential supplies, and minimizing overtime work;

WHEREAS, the income-generating measures shall be made through barangay and/or district by quarterly tax collection campaign period to raise awareness among tax payers and to facilitate tax collection with the doorsteps of the populace;

WHEREAS, the council finds it necessary to explore income-generating measures such as the establishment of LGU-owned businesses or leasing out unused properties for commercial purposes;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. HERMES B. CABALES** the body resolved, as it hereby resolves to enable the Local Chief Executive, Honorable Mayor Junafflor S. Cerilles, RMT, MAGD, to issue Executive Order effecting austerity and income generating measures in the Local Government Unit of Dumalinao, Zamboanga del Sur.
