RESOLUTION NO. 0162-2021

RESOLUTION DECLARING VALID AND OPERATIVE THE ANNUAL BUDGET OF BARANGAY SUMADAT, DUMALINAO, ZAMBOANGA DEL SUR FOR FISCAL YEAR 2021 AMOUNTING TO THREE MILLION EIGHT HUNDRED SEVENTY TWO THOUSAND NINE HUNDRED FORTY FOUR PESOS (Php3, 872, 944.00)

WHEREAS, presented to this august body for appropriate action, the Barangay Annual Budget of Sumadat, Dumalinao, Zamboanga del Sur for CY 2021 with approved Appropriation Ordinance No. 01-2021, subject to all accounting and auditing rules and procedures;

WHEREAS, programs, projects and activities reflected in the budget documents is in conformity with existing laws, rules, and regulations set forth on Book III, Chapter 4, Section 391 paragraph (a). Sub-paragraph (3) of the Local Government Code of 1991 which states that:

WHEREAS, Annual Budget for CY 2021 of Barangay Sumadat was thoroughly reviewed by the Committee on Finance and Appropriation thru technical assistance of the Local Finance Committee and found to be in order and had complied with all the budgetary requirements of the Local Government Code of 1991;

WHEREAS, items appropriated under Appropriation Bill No. 01-2021 of Barangay Sumadat is hereby considered operative in its entirety;

WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

NOW, THEREFORE, premises above-considered, on motion by **HON. ARNOLD L. FLORES** the body resolved, as it hereby resolves to declare valid and operative the Annual Budget for Fiscal Year 2021 of Barangay Sumadat, Dumalinao, Zamboanga del Sur in the amount of Three Million Eight Hundred Seventy Two Thousand Nine Hundred Forty Four Pesos (Php3, 872, 944.00) only.


