CERILLES, DUMALINAO, ZAMBOANGA DEL SUR, TO ENTER INTO A MEMORANDUM AGREEMENT BY AND BETWEEN WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), AND PROVINCIAL GOVERNMENT OF ZAMBOANGA DEL SUR (PGU) FOR THE SPECIFIC IMPLEMENTATION ARRANGEMENT FOR THE KALAHI-CIDSS-KBB BP2 IN DUMALINAO, ZAMBOANGA DEL SUR.**


**WHEREAS**, after careful review and exhausted deliberation, finding the same sound, proper, and in order;


